# Introduction

The Welsh Government wants people in Wales to have happy, healthy lives full of opportunities.

Being outdoors and doing things like gardening is an important part of this.

So we want anyone who wants land for an allotment or community garden to be able to get some.

An allotment is a piece of land you can rent to grow vegetables or flowers on.

A community garden is a piece of land that a group share to plant vegetables and flowers on.

# Allotments and community gardens are important because:

- you get to eat the healthy food;
- they help you keep fit and healthy;
- people from different backgrounds get to work together;
- everyone can take part;
- · you learn about resources like the sun, water, soil, recycling and food;
- they help wildlife and nature;
- more open spaces get used by communities; and
- food doesn't have to travel long distances which is good for the environment.

In Wales we already have the **Community Grow Food Action Plan** that helps to let everyone know about the advantages of growing food and supports communities to grow food in community gardens and allotments.

But we want to do more because there are still many people waiting for land to become available.

This booklet lets you know about our goals and the changes we are considering, including possible changes to the law.

We want to make sure there are enough allotments and land for communities to grow food in every local area.

We want to write new instructions and guidelines for local authorities.

2. We want to help support people who own land to make it available for community food projects.

We want to find more land that could be used so we can have a list or 'bank' of land that people look at to see if they could use it for allotments or community gardens.

Sometimes farmers are afraid a project won't work, the rent won't get paid or the land won't be cared for. We want to look at different ways we can support farmers to make it easier for them to work with communities or school food growing projects.

# Question:

How do you think we can we help farmers make land available?



We want to write a set of rules and guidelines so people know what type of shed or building they're allowed to put up on allotments or community gardens.

People may want to have a small shed or a greenhouse on their allotments. You don't always need planning permission to put these up but there are other things that may need planning permission.

Having a clear set of rules will help everyone to know what is and is not allowed on a piece of land.

5. We want to change what 'allotment' means in law so it covers community gardens and community food growing projects.

Some grow things to sell to help community gardens or school projects. Changing the definition of 'allotment' will help make sure all these types of projects get the help, support and land they need.

6. We want to allow local authorities to let voluntary groups, charities and other organisations run allotments and community garden services for them.

Many local authorities already work with groups who give advice and support to people on growing food, gardening skills and connecting people with projects.

There are many different ways land is managed for allotments and community gardens. Some land is owned by local authorities, some by farmers and some by charities. Having an up-to-date register and a map that clearly shows where land is and what land is available for people to use could really help.

8. We want to put in place a waiting list for community food growing sites.

All communities across Wales should have the same opportunities. We think starting a waiting list will help local authorities to quickly match groups with land and help them understand how much new land is needed for growing.

Having new plans in place could help them work together with charities, voluntary groups and other landowners to find new land faster.
