The Social Services and Well-being (Wales) Act 2014.



This Act is about the future for social care in Wales.



You can find an Easy Read version of the Act on the Welsh Government website.



Everyone in Wales needs to know how to do what the Act says.



This means the Act needs regulations, a code of practice or statutory guidance.

The **regulations** are rules. The rules say what **must** be done.



The **Statutory Guidance** describes what social care will look like and what **must** be done.



The Act starts in April 2016.

We have asked a lot of people what we should put in the **Regulations** and **Statutory Guidance**.



We have written some of the **Regulations** and **Statutory Guidance**.

We have written **Regulations** about:



Adult Protection and Support Orders.



 Safeguarding Boards (we have written two sets of Regulations about this).



• The National Independent Safeguarding Board.



We have also written **Statutory Guidance** about Safeguarding.



You can find them on the Welsh Government website.



Safeguarding is about keeping adults and children safe.



The Act says that if you work for one of these organisations, you **must** tell someone if you think a child or vulnerable adult is at risk.



• Local council.



• Police.



• Probation.



• The NHS.



If you work for one of these organisations, you **must** know:



• who to tell in your own area.



• how to tell organisations in another area.



### **Adult Protection and Support Orders**



We have written **Regulations** about Adult Protection and Support Orders.



This is a new court order.

This is how it works:



 A professional thinks a vulnerable adult may be at risk.



 They have tried to check, but someone is stopping them from seeing the vulnerable adult.



• The professional tells the court.



 The court can give the professional an Adult Protection and Support Order.



 The Order means the professional can go into someone's house without the person's permission.



• Then the professional can check if the vulnerable adult is safe.



# **Safeguarding Boards**



Part 7 of the Act says what the Boards must do.



We have also written **Regulations** about these.



There will be 6 Boards for children.



There will be 6 Boards for adults.

Their job is to make sure professionals work together to keep local people safe.

There will be rules to make sure people who use social care services can work with the Boards.



## National Independent Safeguarding Board
