Summary

The Next Generation Access Broadband Infrastructure Consultation in Wales was undertaken from 9th September 2016 to 9th October 2016. By request, an extension was granted until 04th November 2016 for three respondents.

The purpose of this public consultation was to confirm the areas which do not have Next Generation Access (NGA) broadband infrastructure delivering at least 30Mbps, or where there are no plans to provide such infrastructure over the next three years.

This consultation enabled telecommunications companies and all other interested stakeholders to comment on the proposed NGA intervention area before further coverage is committed.

Background

The Superfast Cymru contract to deliver superfast broadband to a defined intervention area was awarded to British Telecommunications (BT) on 19th July 2012 with State Aid approved public funding of £205m. Following its most recent public consultation between 3rd June and 3rd July 2014, the Welsh Government extended the contract with BT to cover a further defined intervention area with State Aid approved public funding of £19.4m.

The contract with BT includes provisions to ensure that the full amount of public funding is deployed. Additionally, in the event that take-up of superfast broadband services exceeds the forecasts set out in the contract, the amount of public subsidy required would subsequently be reduced to reflect this. Any funds released are then available to be reinvested into further coverage of superfast broadband under the terms of the contract.

In August 2015, BT announced that take-up across the UK was likely to exceed the forecast level of 20%. To date, BT has made available up to £129m across the UK to meet the contractual obligations outlined above. The Welsh Government has received an initial allocation of £12.9m and intends to reinvest this in further coverage under the current contract.

To facilitate this reinvestment at was undertaken public consultation to confirm the areas which do not have

Next Generation Access (NGA) broadband infrastructure delivering at least 30Mbps, or where there are no plans to provide such infrastructure over the next three years. These are described as "White NGA areas".

The consultation invited telecommunications companies and all interested stakeholders to comment on the proposed white NGA areas. The responses would help inform future Welsh Government investment.

This approach was agreed with Broadband Delivery UK. Please note this response is subject to a non disclosure agreement and has therefore not been published.

Correspondence: Consultation response, containing a number of postcodes of past and present customers which have or have received a wireless service and are therefore potentially able to obtain a 30mbps

wireless connection subject to survey. Following a review by the Welsh Government and Broadband Delivery UK the supporting evidence was found to contain significant gaps. This was communicated to ResQ (21/10/16) with a request for further information and an extension until (04/11/16) to provide it. No further correspondence from ResQ was received and therefore the submission was discounted. Please note this response is subject to business confidentiality clauses and has therefore not been published. **Result:** The submission was discounted and not

incorporated within the consultation.

Next Steps

Using the Address Base Premium (Release 34) for Wales as a base data set, the following data sets were applied to the to generate the NGA postcode list.

- Virgin Media consultation response postcodes
- Superfast Cymru tested and verified premises at 24MBps +
- Virgin Media planned roll-out data provided by Broadband Delivery UK.
- BT planned deployment (Superfast Cymru)
- Previous Open Market Review grey and black postcodes
- Open Market Review 2014 City Centre Exclusion Zones
- Airband intervention area premises

Where one or more premise within each postcode is already served or is planned to be served within the next three years, it was removed accordance to the consultation. The remaining list contained 8,513 postcodes, equating to 58,504 premises. This list is therefore defined as the White NGA Area Postcode list.

This list was submitted to and cleared by Broadband Delivery UK's (BDUK) National Competence Centre and will now be used to plan future reinvestment.
