How the views and information you give us will be used

Any response you send us will be seen in full by Welsh Government staff dealing with the issues which this consultation is about. It may also be seen by other Welsh Government staff to help them plan future consultations.

The Welsh Government intends to publish a summary of the responses to this document. We may also publish responses in full. Normally, the name and address (or part of the address) of the person or organisation who sent the response are published with the response. This helps to show that the consultation was carried out properly. If you do not want your name or address published, please tell us this in writing when you send your response. We will then blank them out.

Names or addresses we blank out might still get published later, though we do not think this would happen very often. The Freedom of Information Act 2000 and the Environmental Information Regulations 2004 allow the public to ask to see information held by many public bodies, including the Welsh Government. This includes information which has not been published. However, the law also allows us to withhold information in some circumstances. If anyone asks to see information we have withheld, we will have to decide whether to release it or not. If someone has asked for their name and address not to be published, that is an important fact we would take into account. However, there might sometimes be important reasons why we would have to reveal someone's name and address, even though they have asked for them not to be published. We would get in touch with the person and ask their views before we finally decided to reveal the information.

Purpose of this Consultation

This consultation seeks views on the proposed Welsh Government Prosecution Code (the "Code"). The Code will give guidance to Prosecutors on the principles to be applied when making decisions about Welsh Government prosecutions. This Code will be issued by the Counsel General.

The Counsel General, by virtue of section 45 of the Government of Wales Act 2006 is a member of the Welsh Government. Section 67 of the Act enables the Counsel General to commence prosecutions in the Counsel General's name. There may be occasions where the power to commence a prosecution is reserved to the Welsh Ministers. In those instances, prosecutions will be commenced in the name of the Welsh Ministers.

A draft of the Code is attached to this consultation document.

What is the current position?

At present the decision as to whether a Welsh Government prosecution should be commenced or discontinued is made in accordance with the CPS Code for Crown Prosecutors (the "CPS Code").

Why are we proposing change?

As part of an informal evaluation of procedures it was identified that there is a need for a prosecution code which takes into account specific Welsh Government prosecution functions.

The proposed Code is based on the existing CPS Code. However, the Code specifically takes Welsh Government prosecution functions into account. For example, the public interest factors relate closely to the type of prosecutions that may be commenced by the Counsel General and the Welsh Ministers.

We welcome comments from everyone with an interest in this area. We have identified a number of questions on which we would particularly invite comment:

- 1. Are the roles of the Counsel General and the Welsh Ministers in relation to Welsh Government prosecutions explained clearly enough?
- 2. Is the sufficient evidence stage of the Prosecution Test explained clearly enough?
- 3. Is the public interest stage of the Prosecution Test explained clearly enough?
- 4. Are the public interest factors explained clearly enough?
- 5. Is the relationship between the Code and the Code for Crown Prosecutors explained clearly enough?
