Prosperity for All: Gypsies, Roma and Travellers, replaces the existing Travelling to a Better Future Framework for Action and Delivery Plan which was published in 2011.

In conjunction with colleagues across Welsh Government, the actions within each of the objectives have been derived to address known and continuing issues experienced by the Gypsy, Roma and Traveller communities across Wales.

In accordance with their respective actions, colleagues across Welsh Government will work with relevant stakeholders, partners and the community as specified, to progress, develop and achieve their commitments as outlined in the actions and objectives. This will help to tackle the inequalities and poverty experienced by Communities, to ensure equality of opportunity and to support them to more easily and readily access resources and mainstream services.

**2. We have a legal duty to engage with people with protected characteristics under the Equality Act 2010 (please refer to Annex A of the EIA guidance) identified as being relevant to the policy. What steps have you taken to engage with stakeholders, both internally and externally?**

This consultation proposes a replacement of the existing TTABF Framework for Action and Delivery Plan (2011). It will act as the main vehicle for Welsh Government to work in partnership with stakeholders to adopt a co-ordinated approach to developing and improving access to help, advice and services for the Gypsy Roma and Traveller ('GRT') Community across Wales.

The objectives and actions have been co-ordinated via the setting up of a Cross Government Group and numerous subsequent individual meetings with policy colleagues to agree and finalise actions as relevant.

The consultation will be available online and a series of direct consultation work shops will be undertaken with key stakeholders including Local Authority and Third Sector representatives.

Separate direct consultation events will be conducted with the GRT Community in conjunction with the Travelling Ahead Project. A number of visits to various sites across Wales will also be undertaken to generate feedback on proposals.

**3. Your decisions must be based on robust evidence. What evidence base have you used? Please list the source of this evidence e.g. National Survey for Wales. Do you consider the evidence to be strong, satisfactory or weak and are there any gaps in evidence?**

The existing TTABF Gypsy and Traveller Framework for Action and Delivery Plan has led to significant improvements for the Gypsy and Traveller Community since its inception in 2011. For example 53 residential pitches have been funded by Welsh Government since 2014, following a 17 year period where no new pitches were developed on Local Authority sites.

However, the Framework was limited in scope and did not include the areas of employment, tackling poverty, early years, social care, engagement with Gypsies and Travellers (other than young people); nor did it incorporate the needs of migrant Roma. At the time of publication, issues relating to migrant Roma were to be discussed at the now defunct Migrants Forum. Following a call for proposals relating to migrant Roma in early 2016, it was decided that these issues should be considered.

The new proposals address these gaps within the existing Plan and also includes some additional new commitments in the areas of accommodation, education, health and participation.

The Office for National Statistics analysis of Census 2011 data relating to Gypsies and Travellers provides some very useful, though limited, data regarding inequalities experienced by these communities which has informed the development of the new proposals.
