- 12. The governing body of an educational establishment maintained by a Welsh local authority (within the meaning of section 162 of the Education and Inspections Act 2006)
- 13. The governing body of an institution in Wales within the further education sector (within the meaning of section 91(3) of the Further and Higher Education Act 1992 whose activities are carried on, or principally carried on, in Wales
- 14. An Independent School or special post-16 institution for pupils with special educational needs approved under Section 41(2) of the Children and Families Act whose activities are carried on, or principally carried on, in Wales
