Many thanks for passing this on and for the event on 7th February at which you requested evidence be submitted electronically.

As the chair of ALGAO (the Association of Local Government Archaeological Officers) Cymru I would like to highlight the importance of integrating historic environment issues into the National Development Framework and the importance of the emerging framework being supported by my colleagues within Cadw at a national level as well as through consultation with Local Authority historic environment specialists and those within the Welsh Archaeological Trusts. Whilst the Historic Environment will doubtless be considered in strategic decision making for developments of national significance, policy all too often focusses on the constraints of historic environment rather than the potential benefits and opportunities. The goals set out in the wellbeing of future generations act highlight the need for both the protection and promotion of culture and heritage and I would hope that the NDF will be able to acknowledge the important role the historic environment plays as a national asset and encourage opportunities to preserve as well as enhance historic assets.

I would welcome future consultation and engagement during the development of the NDF.
