The Welsh Government published a Refugee & Asylum Seeker Delivery Plan in March 2016. In April 2017, the National Assembly for Wales Equality, Local Government and Communities Committee published their "I used to be someone"; Refugees and Asylum Seekers in Wales report which made a number of recommendations to improve the lives of refugees and asylum seekers (RAS) in Wales. Recommendation 1 was that the Welsh Government should review and consult on a revised plan.

The new plan has been developed in line with the Well-being of Future Generations Act (Wales) 2015 'five ways of working' and co-produced in partnership with organisations outside of the Welsh Government. It has also been aligned to reflect the priorities in Prosperity for All. This will help to tackle the inequalities and poverty experienced by refugees and asylum seekers, ensure equality of opportunity and support them to more easily access resources and mainstream services.

The decision to rename the plan as the Welsh Government Nation of Sanctuary Refugee & Asylum Seeker Plan reflects the Welsh Government's commitment to supporting the aims and objectives of the Sanctuary movement and to delivering better outcomes and improve integration for RAS.

Equality team officials held a series of engagement events with refugees and asylum seekers themselves in autumn 2017 and used these as the basis for the development of the plan. The actions have been developed by series of meetings with policy colleagues and the external organisations who offer support and advice to RAS. It was an iterative process to refine the actions and to ensure that they are deliverable.

The consultation will be available online and a series of direct consultation work shops will be conducted by the Asylum Rights Programme. We will also encourage the Welsh Refugee Coalition and others to discuss these proposals with those they support.

We are considering whether to hold further direct engagement events with RAS during the consultation period.

The existing Welsh Government Refugee and Asylum Seeker delivery plan contained eight action areas which were intended to deliver outcomes to improve the experiences of RAS in Wales.

In the development of that plan, officials, used the available data and sources of information to ensure that the policy proposals were evidence based.

The Equality, Local Government and Communities Committee (ELGCC) launched an inquiry into refugees and asylum seekers in Wales in 2016, largely in response to the refugee crisis exacerbated by the conflict in Syria.

The Committee published their inquiry report, entitled "I used to be someone", in April 2017. The Committee made 19 recommendations for the Welsh Government to implement in order to improve the lives of RAS. We have used the evidence submitted as part of the Committee Inquiry, supported by direct engagement with 120 refugees and asylum seekers, and co-production with the Welsh Refugee Coalition to ensure these proposals are fit for purpose. Therefore, we believe the plan is based upon robust evidence of needs.

Asylum policy is the responsibility of the Home Office and many of the actions which would improve the lives of asylum seekers and refugees are not within the competence of the Welsh Government. Through discussion with the providers of services which are devolved to the Welsh Government, the accessibility and quality of these services to refugees and asylum seekers should be improved.

The consultation process will help to improve and/or enhance the proposals and highlight any further gaps or inconsistencies that may be identified during the process to ensure far reaching and effective delivery.

Nevertheless, there is a dearth of quantitative data relating to refugees and asylum seekers in Wales. One of the proposals in the plan includes establishing a data and evidence group to try to improve data collection and sharing in future.
