1. Please provide a brief description of the policy/decision.

The Social Services and Well-being (Wales) Act 2014 ('the 2014 Act') came into force on 6 April 2016.

Part 10 of the Act includes duties relating to advocacy. The dedicated code of practice on advocacy under Part 10 sets out how advocacy could support the determination and delivery of an individual's personal outcomes, together with the circumstances when a local authority must arrange an independent professional advocate. Chapter 3 of Part 10 of the Act relates to advocacy for children and adults.

Section 174 of the 2014 Act also requires local authorities to provide advocacy in respect of representation or complaints by a child in relation to services received either as a looked after child or a child in need of care and support. A "looked after child" is a child who is either in the care of a local authority or is provided with accommodation under a local authority's functions under part 6 of the 2014 Act.

Commissioners of independent professional advocacy services under Section 174 need a consistent framework to measure the quality as well as the quantity of their work and be assured they are making a positive difference to children and young people's lives. As a result Ministers invited local government in Wales to bring forward a model for securing a national approach to statutory independent professional advocacy for looked after children, children in need of care and support and other specified individuals.

A Senior Leadership Group, which included the Children's Commissioner for Wales, was established to oversee the development of the National Approach. The group completed its work having identified (and developed) the following key components:

- National Standards and Outcomes Framework including an approach to the 'active offer' of advocacy identified in 'Missing Voices' and a mapping of the National Standards and Outcomes Framework to the Well-being Statement that underpins the 2014 Act.
- National Approach Regional Service Specification providing consistent specifications for commissioning of services.
- National Approach Regional Performance Reporting Template delivering the evidence and statistics identified within the National Standards and Outcomes Framework for service quality and performance monitoring purposes.
- A Range and Level Assessment Mechanism (Service Capacity) which assists with gauging service capacity requirements and associated costs.
 The CYP Framework intends to:
- replace the National Standards for the provision of Children's Advocacy Services (2003) and identifies the outcomes children and young people can expect in relation to children and young people's advocacy.

- ensure that advocacy service providers and those commissioning them can be sure those standards are being achieved, enabling them to evidence they are making a positive difference to children and young people's lives.
- link the standards to the overarching Well-being Statement under the 2014 Act and demonstrate how local authorities can evidence how children and young people will be supported to achieve their well-being outcomes through accessing advocacy.
- provide children with care and support needs who access advocacy services with information about what they are entitled to, and how they can be involved in developing and evaluating the services.

The National Standards and Outcomes Framework for Children and Young People in Wales ('CYP Framework') replaces the above mentioned national standards for the provision of Children's Advocacy Services (2003). There is parallel work underway on the requirements for independent professional advocacy services under the Regulation and Inspection of Social Care (Wales) Act 2016 ('the 2016 Act') which will apply to children in Wales. These two pieces of work must be closely aligned to avoid any confusion for commissioners and providers.

This Equality Impact Assessment relates to the National Standards and Outcomes Framework for Children and Young People in Wales ('CYP Framework') which is linked to the Code of Practice on the exercise of social services functions in relation to Advocacy under Part 10 and related parts of the Social Services and Wellbeing (Wales) Act 2014 (the Act).

Children and young people are automatically entitled to a statutory independent professional advocate when they become looked after or are included on the Child Protection Register. The 'active offer/ is made directly to the child or young person by the Advocacy Service. The CYP Framework provides guidance on how the active offer should be delivered.

2. We have a legal duty to engage with people with protected characteristics under the Equality Act 2010 (please refer to Annex A of the EIA guidance) identified as being relevant to the policy. What steps have you taken to engage with stakeholders, both internally and externally?

The National Independent Advocacy Standards and Outcomes Framework for Children and Young People in Wales ('the Framework') was consulted on to seek views. A young person friendly version of the Framework was also produced.

Engagement has reached as many individuals as possible to ensure that the Welsh Government equality commitments have been incorporated into the development of the policy from the outset. This has improved the understanding of barriers that exist in different equality groups.

As well as formal consultation, using various formats, officials gave presentations to groups, held discussions, attended one to one meetings, encouraged people to

invite them to their existing meetings, and wrote articles and gave them to our partners to use within their networks. Stakeholders were asked to share information with their networks and feed back to Welsh Government.

As well as key contacts being encouraged to disseminate the consultation documents amongst their networks, to support wider engagement, easy read and children and young-people friendly versions were also produced and disseminated.

As well as being made available to the wider public via the Welsh Government internet pages, the consultation was distributed to key stakeholders including the following:-

Consultation Events

One consultation event with Voices from Care was held as part of the consultation process. The purpose of these was to:

- promote engagement with the consultation with children and young people;
- provide a base level of understanding to children and young people on the areas we were consulting on.

Attendees were asked to participate in discussions on the implementation of the regulations, and also to share information from the events with their wider networks to provoke deeper engagement with the proposals and a wider span of consultation responses.

The comments and outputs from the event were considered alongside the formal written responses.

This document identifies the outcomes children and young people can expect in relation to children and young people's advocacy. It sets out a framework by which advocacy service providers and those commissioning them can be sure those standards are being achieved, enabling them to evidence they are making a positive difference to children and young people's lives.

The Standards and Outcomes Framework (the Framework) builds on the foundations of, and is cross-referenced to, the original National Standards for the provision of Children's Advocacy Services (2003) which it replaces. It should be read alongside A guide to handling complaints and representations by local authority social services (August 2014).

These standards have been consolidated into standards and outcomes statements for which there is then more detailed information on how commissioners and advocacy providers can evidence/ measure how they are meeting them. They are linked to and underpin the overarching Wellbeing Statement (Appendix A) and will demonstrate how local authorities evidence how children and young people will be supported to achieve their well-being outcomes by accessing advocacy i.e. 'Securing rights and entitlements', 'Protection from abuse and neglect'.

This document also provides children and young people with care and support needs who access advocacy services, with information regarding what they are entitled to, and how they can be involved with developing and evaluating the services.

A young person friendly version of the Framework has been produced for consultation.

1.2 How could / does the policy / decision help to eliminate unlawful discrimination, harassment or victimisation?

The Act promotes equality, improvements in the quality of services and the provision of information people receive. To promote consistency the Code sets out when a local authority must consider individuals needs for advocacy, the circumstances when individuals may require, commissioning an effective service and publishing advocacy services. The Framework will adhere to the Code.

1.3 How could/does the policy impact on advancing / promoting good relations and wider community cohesion?

Through direct engagement and consultation with different service users and equality groups, Welsh Government gained an understanding of individuals own personal barriers and rights that needed to be overcome. Welsh Government supports individuals to achieve well-being by recognising and valuing people's strengths, people's families, friends and communities. Local authorities will work with all individuals to identify what matters to them, and identify the contribution people themselves and communities can make to their own well-being. This may include assisting individuals to seek support or assistance within the local community, such as community based third sector services or social care enterprises. This includes whether a person feels as though they belong, whether they engage and participate and feel valued in society, which is especially important for people who may feel particularly vulnerable because they fall under the protected characteristics.
