1. Introduction

- 1.1 Regulation (EC) No 1760/2000 of the European Parliament and of the Council of 17 July 2000 sets out the European Union (EU) system for the identification and registration of bovine animals as well as the requirements in respect of labelling beef and beef products, including the labelling of meat (including offal) of bovine animals aged 12 months or less and the labelling of pre-packed and non prepacked beef products.
- **1.2** The aim of the legislation was to strengthen traceability controls against the risk of contaminated products entering the food chain and causing a human health risk.
- **1.3** This legislation is currently implemented in Wales *via* the Beef and Veal Labelling (Wales) Regulations 2011 which provide enforcement powers in relation to the voluntary European beef labelling obligations set by Regulation (EC) 1760/2000.
- 1.4 The above European legislation has now been updated by Regulation (EU) No. 653/2014 which amends Regulation (EC) No 1760/2000 as regards the labelling of beef. The amendments remove the voluntary labelling scheme to reflect the general labelling principles set by Regulation (EU) No 1169/2011 of the European Parliament and of the Council on the provision of food information to consumers. As a result the Beef and Veal Labelling (Wales) Regulations 2011 also need amending.

2. Purpose of the consultation

2.1 The main purpose of this consultation is to inform you of, and seek your views on, the removal of the voluntary labelling scheme and the updating of our domestic regulations to reflect the general labelling principles in respect of the provision of food information to consumers.

Who will be affected by the proposal?

- **2.2** This consultation is directed at individuals who are involved in the meat processing industry in Wales and principally anyone with an interest in the regulation of Beef and Veal labelling and the labelling of food products. It will be of particular interest to you if you are:
 - Engaged in activities associated with meat processing
 - Engaged in activities for the benefit of the Beef and Veal Labelling industry

Timing of the consultation

- **2.3** This consultation will run for 4 weeks from 28/08/2018 and close on 25/09/2018. We will not consider responses received after that date.
- **2.4** We have been engaging with industry stakeholders and have made them aware of both the purpose and schedule of this consultation.

3. Proposal

Beef and Veal Labelling (Wales) – what is this consultation about?

3.1 What the present voluntary labelling regime requires

The Beef and Veal Labelling (Wales) Regulations 2011 provide enforcement powers for the Welsh Ministers to ensure compliance with the EU beef labelling regulations as set out in EC Regulation 1760/2000.

These require beef and veal (but not mince or trimmings) to be labelled with a unique number allowing meat to be traced back to an identifiable animal or group of animals; the country of birth of the animal (s) in question; the country/ies of rearing of those animals; the country of slaughter of those animals; and details of the slaughterhouse and cutting plant (where applicable).

In addition to the above statutory labelling requirements, voluntary claims concerning where the animal or animals from which the beef was derived were born, fattened and slaughtered may be provided under the voluntary beef labelling system. Prior to including such information on a label however, any voluntary claim had to have been submitted for approval via the EU.

3.2 What the new mandatory regime will require

The main effect has been to remove the voluntary claims aspect of the labelling scheme which are now included in the general labelling principles set by the Food Information to Consumer Regulations (Regulation (EU) 1169/2011).

The general labelling principles now prescribe how such claims regarding derivation or slaughter etc. should be included on any label. This makes it easier to place the claims outlined above when labelling beef and veal as they do not have to be submitted for approval in advance. This will simplify the process for making such claims on beef and yeal labels.

Whilst the UK remains a member State of the EU, our domestic regulations need to reflect the position in EU law and also require insertion of updated references to other EU regulations which have been overhauled. As amendments were made to the Regulation (EC) 1760/2000 by Regulation (EU) 653/2014, those amendments now need to be reflected in our domestic legislation.

Welsh Government has been advised that England will be bringing amending regulations (and a number of other regulatory changes) into force using a similar Statutory Instrument. It is advisable for the Welsh regulations to remain parallel because the nature of trade in meat and animal products requires a seamless approach across England and Wales. As the inspection agencies and enforcement authorities work on an England and Wales basis and to the same specifications parallel regulations will ensure that there is no market distortion and less risk of failures occurring within the supply chain.
