Introduction

The Park Home Commission Rate is a fee payable to the site owner when a park home is sold. In Wales this is set at a maximum of 10% of the purchase price of the park home. In practice, this means that the amount a seller receives when they sell their park home is reduced at the time of sale, as 10% of the sale price is required to be paid to the site owner. The current commission rate is set by regulations made under the Mobile Homes (Wales) Act 2013 and has remained at 10% since 1983 when an order set the rate at 10%.

There is a power for the Welsh Ministers under the Mobile Homes (Wales) Act 2013 to prescribe the commission rate in regulations. On 5 June 2018, the Minister for Housing and Regeneration, Rebecca Evans AM, announced her decision to lower the commission rate by 1 percentage point per year, over a 5-year period, until it is reduced to a maximum of 5% of the purchase price.

This decision followed a 12 week consultation which gave both residents and site owners the opportunity to have their say. The consultation ended in August 2017, having received almost 400 responses. Independent financial analysis was also commissioned.

This consultation does not revisit the decision to lower the rate. Views are however being sought as to how the decision is implemented. The questions focus on how best to introduce the reduction, what guidance is needed to support the change (if any) and how best to communicate that change.

The Mobile Homes (Selling and Gifting) (Wales) (Amendment)
Regulations 2019

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend regulation 8 of the Mobile Homes (Selling and Gifting) (Wales) Regulations 2014 ("the 2014 Regulations"). They prescribe the maximum rate of commission which is payable to the site owner by the new occupier of a mobile home upon the sale of a mobile home under paragraphs 9 and 10 of Chapter 2 of Part 1 of Schedule 2 to the Mobile Homes (Wales) Act 2013 ("the 2013 Act").

Regulation 2 substitutes a new regulation 8 into the 2014 Regulations and provides that from 1 April 2019 the maximum rate of commission is to be reduced to 5% from the current rate of 10% over a five year period, by means of an annual reduction of 1% until 2023 when the prescribed rate of commission will be 5% of the purchase price of the mobile home.

Regulation 3 revokes the Mobile Homes (Commissions) Order 1983 ("the 1983 Order") in relation to Wales. The 1983 Order set the maximum rate of commission at 10%, to which an owner was entitled under paragraph 8 of Chapter 2 of Part 1 of Schedule 1 to the Mobile Homes Act 1983 on the sale of a mobile home by an occupier. By virtue of article 4(6)(b) of the Mobile Homes (Wales) Act 2013 (Commencement, Transitional and Saving Provisions) Order 2014, the 1983 Order continued to have effect for the purpose of determining the amount of commission due to the owner where there was a sale of a mobile home and assignment of the agreement after 1 October 2014, when changes made to the sale of a mobile home under the 2013 Act came into force.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, a regulatory impact assessment has been prepared as to the likely costs and benefits of complying with these Regulations. The Welsh Ministers make the following Regulations in exercise of the powers conferred on them by section 63(9) of, and paragraphs 9(4) and 10(8) of Chapter 2 of Part 1 of Schedule 2 to, the Mobile Homes (Wales) Act 2013(1).

In accordance with section 63(5)(c) of that Act, a draft of this instrument was laid before and approved by a resolution of the National Assembly for Wales.

Title and commencement

The title of these Regulations is the Mobile Homes (Selling and Gifting) (Wales) (Amendment) Regulations 2019 and they come into force on 1 April 2019.

Amendment of regulation 8 of the Mobile Homes (Selling and Gifting) (Wales) Regulations 2014

- —a) The Mobile Homes (Selling and Gifting) (Wales) Regulations 2014(2) are amended as follows. For regulation 8 (maximum rate of commission payable on the sale of a mobile home) substitute—
 - "8. The rate prescribed for the purposes of paragraphs 9(4) and 10(8) of Chapter 2 of Part 1 of Schedule 2 to the 2013 Act is—
 - (a) 9% of the purchase price of the mobile home from XXX;
 - (b) 8% of the purchase price of the mobile home from XXX;
 - (c) 7% of the purchase price of the mobile home from XXX;
 - (d) 6% of the purchase price of the mobile home from XXX; and
 - (e) 5% of the purchase price of the mobile home from XXX."

Revocation

The Mobile Homes (Commissions) Order 1983(3) is revoked in relation to Wales.
