Introduction

We are working with Capita Real Estate and Infrastructure on proposals to address issues of concern on the current highway network within the settlements of Llandeilo and Ffairfach

We have reviewed a number of options to improve the highway network and we are now seeking your feedback on these differing proposals.

What are the main issues?

The following were identified as some of the main issues of concern:

- Safety;
- Traffic Speed;
- Network constraints;
- Parking;
- Seasonality of traffic flow;
- Insufficient diversion routes:
- Non-Motorised Users environment;
- No cycling infrastructure;
- Non-Motorised Users wayfinding;
- Public transport quality;
- Pollution; and
- Noise.

What will happen if nothing changes?

- If the A483 and surrounding road network remains unaltered, the existing traffic congestion, particularly at the pinch point in front of the Cawdor within Llandeilo, will remain.
- The congestion and idling vehicles immediately alongside residential areas will continue to have an adverse effect on noise and air quality.
- The townscape and cultural heritage will continue to suffer adverse effects due to the congestion within a Conservation Area and alongside listed buildings.
- There will be a continued slight adverse impact upon journey time changes/reliability, physical activity, journey quality, accidents, access to employment/services, severance and active travel.

Where are we now?

The consultation is an important step in the Welsh Transport Planning and Appraisal Guidance (WelTAG 2017) process, providing feedback on the WelTAG Stage 1: Outline Case undertaken by Jacobs UK Limited (Jacobs) and Mott MacDonald.

The Outline Case at Stage One will inform the WelTAG Stage Two: Outline Business Case study for which we have appointed Capita Property and Infrastructure to undertake. The WelTAG Guidance ensures that the selected scheme:

- shows value for money
- provides transport, economic, social and environmental benefits
- delivers maximum benefit with minimal impact

As part of the Stage Two review, a preferred option will be identified.

What options are we considering?

Based on the appraisal, the highest scoring options and therefore those which are recommended for further consideration at WelTAG Stage Two are summarised below

NB1: Traffic lights, no bypass

NB2: Removal of parking, no bypass

NB5: HGV Restriction (legal sanction) plus one-way system

NB6: Combined No bypass Option (with HGV restriction)

NB7: Combined No bypass (No HGV restriction)

TC1A: One-way system and bypass

BE1A: Eastern Bypass Option 1 (A)

BE1B: Eastern Bypass Option 1 (B)

BE1C: Eastern Bypass Option 1 (C)

BE4D: Mid Rhosmaen Eastern Bypass Option 4 (D)

BE6: Eastern Bypass Option 6

For those options in excess of £60 million, a staged approach is envisaged with full completion based on monitoring and funding as the scheme progresses. The additional tails bypassing Ffairfach as denoted on the following routes BE1A, BE4D and BE6 can only be facilitated if additional funding was granted.

The preferred options identified have no status. They have been agreed as the basis for consultation by a Review Group of key stakeholders.
