Many of the rural communities and jobs rely on development and evolution of rural Wales. Failure to recognise timber as a raw industrial commodity highlights the disconnect between products we grow in Wales and how we can utilise them.

Cities and large towns [...] Development plans will enable and support aspirations for large towns and cities to grow, founded on sustainability and urban design principles – this means a strategy for low-carbon building; that means shifting from non-renewable materials to timber.

Policy 3. Timber construction methods should be used wherever possible, to reduce environmental costs and help achieve climate change targets.

Development Plans will have a forward thinking, positive attitude towards enabling economic development, investment and innovation – that raises serious questions about how we run our countryside especially in the context of understanding local issues and geography. The Welsh Gov. priorities on habitat, species, land use and community support will have to strike a fine line between defaulting to protecting everything from development and allowing inappropriate decisions that threaten areas of critical importance.

Policy 9. We support the target to increase woodland cover in Wales by at least 2,000 ha per year from 2020 but this does not go far enough. The inclusion of the National Forest Policy is strongly welcomed. At present the relationship between this, Area Statements the Woodland Strategy and the NDF is muddled and some cohesive development of these policies and program objectives should be clarified with key strategic points being included in the NDF.

To achieve what must be considered a minimum target of 2000ha a year needs substantial action and is required at ministerial level. This Political direction is required to ensure delivery partners specifically RPW and NRW look at their policies with a presumption in favour of planting.

Wales has 138,000 hectares of privately-owned broadleaf woodland, the majority of which is unmanaged. The State of Nature report identified lack of management as a major factor in biodiversity decline in Wales. Bringing this woodland into sustainable management through activities like thinning, pruning, replanting, fencing, and grey squirrel control, would not only transform its value for biodiversity, it would increase its capacity to store carbon, reduce flooding, improve air quality, and also sustainably yield around 1 million tonnes of biomass per year which could contribute to a joined-up renewable energy policy.

National forest: There is evidence that large mixed forests, connected to existing woodlands and forests, are better for biodiversity than scattered unmanaged fragments. All forests should have a future management plan including a funding plan: the wood that stays is the wood that pays.

Solar systems should look to be place in conjunction with new housing and industrial development with a retrofit policy for industrial/commercial premises.

District heat systems have the capacity to provide more efficient heat distribution and generation. The role of waste must be considered seriously as the emphasis for biomass cannot be placed entirely on forest products. The co-products resulting from forestry operations and timber processing may have more valuable uses ecologically and commercially than in heat generation.

The NDF identifies three overall regions of Wales, each with their own distinct opportunities and challenges. These are North Wales, Mid and South West Wales, and South East Wales.

9. North Wales (policies 17-22)

We have identified Wrexham and Deeside as the main focus of development in North Wales. A new green belt will be created to manage the form of growth. A number of coastal towns are identified as having key regional roles, while we support growth and development at Holyhead Port. We will support improved transport infrastructure in the region, including a North Wales Metro, and support better connectivity with England. North West Wales is recognised as having potential to supply low-carbon energy on a strategic scale.

A green belt around Newport and eastern parts of the region will support the spatial strategy and focus development on existing cities and towns. Transport Orientated Development, using locations benefitting from mainline railway and Metro stations, will shape the approach to development across the region. There is support for the growth and development of Cardiff Airport.

12. Integrated Sustainability Appraisal

The variety of flora and fauna found across Wales make Wales a special place. This is true but the most neglected part is the indigenous Celtic rainforest; we need a drive for a lot more woodland and positive management.
