Nurse Staffing Levels (Wales) Act 2016 – Revised Statutory Guidance

Amendments made to the statutory guidance to include paediatric
inpatient wards

Overview

This consultation seeks your views on a revised draft of statutory guidance required by section 25D of the NHS (Wales) Act 2006, as amended by the Nurse Staffing Levels (Wales) Act 2016.

The guidance relates to sections 25B and 25C of the 2006 Act; the duties to calculate and take steps to maintain nurse staffing levels, and to the method of calculation.

The guidance has been amended to include references to paediatric inpatient wards, to which sections 25B and 25C will be applied from October 2021.

What are the main issues?

1. Sections 25B and 25C of the NHS (Wales) Act 2006, as inserted by the Nurse Staffing Levels (Wales) Act 2016, place duties on Local Health Boards (LHBs) and NHS trusts (Trusts) in Wales to calculate and maintain the nurse staffing levels for adult acute medical inpatient wards and adult acute surgical inpatient wards. The rationale for applying the duties only in these settings was that section 25C mandates the use of an evidence-based workforce planning tool for the calculation process, and in 2016, adult acute medical and surgical inpatient wards were the only settings with a sufficiently developed evidence-base to create such a tool (the Welsh Levels of Care).
2. However, since the duties came into force within those settings, the All Wales Paediatric Nursing Group has spearheaded the development and testing of a Welsh Levels of Care tool for paediatric inpatient settings. Following this work, the Welsh Government has therefore decided to extend the duties in sections 25B and 25C to paediatric inpatient wards. Individual work-streams of the All Wales Nurse Staffing Group are working to develop similar tools for other nurse settings, and the potential to extend these duties to those settings will remain under review.
3. Section 25D requires the Welsh Ministers to issue guidance about the duties under sections 25B and 25C, to which LHBs and Trusts must have regard when exercising their duties under those sections. Statutory guidance was originally published in November 2017, applying only to adult medical and surgical inpatient wards.
4. This consultation relates to the minor changes to that statutory guidance, necessary in light of the decision to extend the duties to paediatric inpatient wards.
5. Areas not covered within the guidance, such as reporting and monitoring may be included in future, non-statutory guidance.

Where are we now?

6. The COVID 19 pandemic inevitably caused significant disruption both to the work of the All Wales Nurse Staffing Group (which oversees the development of the evidence-based workforce planning tools required by the Act), and to LHBs' own preparations for the extension of the duties into paediatrics.
7. Consequently, in March 2020, the Minister for Health and Social Services made the decision to postpone this consultation, from the summer months as planned, enabling the NHS to focus on the pandemic response.
8. Similarly, the Minister has agreed to a flexibility on the coming-into-force date of the regulations necessary to extend the duties (originally envisaged for April 2021), to allow time for services to overcome the unforeseen delay to preparations. October 2021 is now the target coming-into-force date, however, this may be subject to further necessary change.

9. At present these regulations, to be made under section 25B(3)(c), are scheduled for debate by the Senedd in February 2021.

Amendments to the statutory guidance

10. The revised statutory guidance is included at Annex 2, with all amendments clearly tracked. The changes broadly fall into three categories:
- a) Inclusion of a definition for paediatric inpatient wards and corresponding alterations to the existing definitions of adult medical and surgical inpatient wards (paragraphs 28 – 30);
 - b) The addition of a list of care settings that would be excluded under the definition of paediatric inpatient wards (paragraph 30); and
 - c) Amendments to the general narrative, to reflect the updated position of sections 25B and 25C applying to these additional settings.

There are also minor typographical or formatting alterations to the original document (throughout). Specific instances are further explained by comments where appropriate.
