Summary

Section 144B of the Social Services and Well-being (Wales) Act 2014 ('the 2014 Act') requires local authorities to prepare and publish market stability reports. It also makes provision for regulations. It is the Welsh Government's intention to commence section 144B (in part), and bring into force a set of regulations, by April 2021.

Welsh Government also intends to use the regulation-making powers around partnership working in the 2014 Act, to require local authorities and Local Health Boards to undertake these functions in partnership, and to produce one market stability report for each of the seven Regional Partnership Board (RPB) area.

The regulations will be supplemented by a code of practice for local authorities, on the exercise of their functions in relation to market stability reports, and statutory guidance for local authorities and local health boards on taking a partnership approach to preparing and publishing market stability reports for each RPB area.

This consultation seeks views on draft regulations, a code of practice and statutory guidance.

What are the main issues?

Local authorities and local health boards already have a duty, under section 14 of the 2014 Act, to work with the local health board to assess the care and support needs of their local populations and the services that are required to meet those needs. The population needs assessments must be produced on a regional footprint, with local authorities and local health boards working together through the RPBs to produce a combined assessment for each RPB area. The first population needs assessments were published in April 2017.

Section 144B, which was inserted into the 2014 Act by the Regulation and Inspection of Social Care (Wales) Act 2016, requires local authorities to assess the sufficiency of the care and support provided to meet the needs of the local population, and to assess the stability of the market for regulated care and support services. Whereas the population needs assessments deal with demand, market stability reports will consider sufficiency in supply in meeting that demand.

Local authorities and local health boards are also required to work in partnership through the RPBs to produce area plans under section 14A of the 2014 Act. These plans are key strategic documents which set out the range and level of care and support the RPB partners propose to provide (or arrange to provide) in response to the population needs assessment. The first plans were published in April 2018. Population needs assessments and area plans must be produced every five years, aligned with the local government electoral cycle.

Our intention is to replicate these arrangements for market stability reports, so that their preparation overlaps with the population needs assessment and feeds into the area plan. We propose that the first market stability reports are published by 1 June 2022, three months after the next population needs assessments, and feeding into the area plans which are due in April 2023.

What are we proposing?

Welsh Government proposes to commence section 144B before the end of this Senedd term, in order to give the RPBs a good lead-in time before the first market stability reports are due. We are aware of long-standing pressures on the social care market, which have been exacerbated by the impact of the Covid-19 pandemic. Our proposals for market stability reports are designed to ensure that local authorities and Local Health Boards have undertaken an assessment of the sufficiency of care and support across the RPB area, and have an up-to-date and comprehensive picture of the composition and characteristics of the market for regulated services, so that they can make confident and informed judgements about provision, and commission a diverse range of services which meet local need and help promote good outcomes for people who need care and support.

Welsh Government proposes to commence section 144B and to bring into force regulations which will:

- require local authorities and local health boards to work in partnership to prepare and publish market stability reports for each of the RPB areas
- specify that the following matters must be considered with respect to regulated services:
 - o the sufficiency of regulated services providing care and support
 - o overall quality of regulated care and support services
 - current or developing trends in regulated services providing care and support
 - significant challenges to current or future provision of regulated care and support services
 - impact of commissioning and funding of care and support.
- specify that the period of assessment will be the period since the latest population needs assessment was published
- require market stability reports to be published in an electronic form on their websites by 1 June 2022, and subsequent reports every five years

Welsh Government also proposes to bring into force a code of practice under section 145 of the 2014 Act, on the exercise of local authority functions in relation to market stability reports, and statutory guidance for local authorities and local health boards under section 169 of the 2014, on working in partnership to prepare and publish these reports on a regional basis.

The code of practice and statutory guidance include additional requirements to:

- engage with providers or potential providers of care and support services across the public, private and third sectors
- take reasonable steps to engage with citizens, particularly adults and children who need care and support, and carers who need support
- appoint a lead co-ordinating body to carry out the assessment and prepare and publish the market stability report
- keep market stability reports under regular review and produce revised reports or an addendum as necessary.

What do we want to know?

Welsh Government would welcome comments on the draft regulations, code of practice and statutory guidance from local authorities, local health boards, and other organisations or sectors which are represented on RPBs or have an interest in the provision of care and support to the local population. It would also welcome comments from members of the public, including especially individuals who need care and support, and carers who need support.
