This consultation seeks views on the relaxation of The School Reporting Requirements (Wales) (Coronavirus) Regulations 2021 which would come into force in Summer 2021, as a result of proposed changes to relax burdens on schools and local authorities in Wales.



Background

1. The Welsh Government recognises that, during this time, when we are all responding to the coronavirus pandemic, schools, local authorities and governing bodies may be unable to comply with certain statutory requirements. They may also pose a disproportionate administrative burden on those responsible, at a time when they are already stretched. In response to this, in August 2020, we brought into force amending Regulations that revoked the school performance and absence target setting regulations and relaxed a number of other school reporting requirements for the 2019/20 school year. We are proposing to bring into force similar amending regulations, where required, for 2020/21.

Proposal

- 2. The Relaxation of School Reporting Requirements (Wales) (Coronavirus) Regulations 2021 will:
- Amend The School Information (Wales) Regulations 2011 for the school year 2020/21.
- Amend The School Governors' Annual Reports (Wales) Regulations 2011 for the school year 2020/21.
- Amend The Head Teacher's Report to Parents and Adult Pupils (Wales)
 Regulations 2011 for the school year 2020/21.
- Amend The School Performance Information (Wales) Regulations 2011 for the school year 2020/21.

Next Steps

- 3. You are invited to submit your views on this proposal. Responses should be emailed by 26 March 2021 at the latest. Responses to consultations are likely to be made public on the internet or in a report. If you would prefer your response to remain anonymous, please indicate in your response.
- 4. Subject to the outcome of this consultation, we propose that these changes will come into force in the summer term 2021.

Legislative detail and the proposed amending Regulations

5. Current school reporting arrangements are underpinned by a suite of Regulations and statutory guidance. The proposed amending Regulations will amend four sets of Regulations which place duties on governing bodies and local authorities to report information about their schools. The Regulations amended are listed below.

The School Information (Wales) Regulations 2011 ("the School Information Regulations")

6. The School Information Regulations require local authorities to publish a composite school prospectus and schools to publish their own individual prospectus, and prescribes the school information that must be included. It is proposed that provision is made to exclude data on authorised and unauthorised absences in respect of pupils registered at the school in the 2020/21 school year from being published in any school prospectus.

The School Governors' Annual Reports (Wales) Regulations 2011 ("the Annual Report Regulations")

- 7. The Annual Report Regulations require school governing bodies to produce an annual report, including information about school performance against published targets. Whilst governing bodies will be still be able to produce a report, it would be inappropriate for reports produced in respect of pupils registered at schools in the 2020/21 school year to include performance and attendance data, as it will not be comparable to previous years. It is proposed that the Annual Report Regulations are amended to modify the content of reports produced in relation to the 2020/21 academic year so that information may not be included in any school governors' report. The statutory duty for governing bodies to produce a report will remain.
- 8. Information to be disapplied/excluded in relation to pupils registered at the school in the 2020/21 school year:
- the most recent Summary of Secondary School Performance (SSSP);
- the number of authorised and unauthorised absences in the school year; and
- any information in relation to performance and absence targets, including improvements set by the governing body in respect of performance of learners, or for reducing the level of absence. (The School Performance and Absence Targets (Wales) Regulations 2011 were revoked in August 2020).

The Head Teacher's Report to Parents and Adult Pupils (Wales) Regulations 2011 ("the Reporting Regulations")

9. The Reporting Regulations require headteachers to make a report available to all parents or adult pupils about the educational achievements of pupils, each school year. For the 2020/21 school year, in order to provide assurance of progress to parents, the provision of reports in respect of all learners will remain an absolute duty. In accordance with the Regulations, reports must be made available to parents and adult pupils by 30 September 2021. We recognise, however, that some information that would ordinarily be included in a report, will be either unavailable, not meaningful, or considered inappropriate. It is proposed that Regulation 3(3) of the Reporting Regulations, that specifies the content for reports about the educational achievement of pupils, is amended to a "reasonable endeavours" basis. This means that any duties that this Regulation imposes on headteachers for the content of reports relating to the 2020/21 school year, is to be treated as discharged, if the headteacher has used reasonable endeavours to discharge the duty. Headteachers must continue to provide relevant and useful reports on progress for all pupils, drawing on teachers' knowledge of their pupils and the information available to them.

The School Performance Information (Wales) Regulations 2011 ("the Performance Regulations")

10. The Performance Regulations provide for the reporting of teacher assessment, national test and examination outcomes (from schools and governing bodies to local authorities and Welsh Ministers). Not all schools will have completed their foundation phase or key stage teacher assessments or tests during the 2020/21 school year, which have remained subject to "reasonable endeavours". It is, therefore, proposed that amendments are made to remove the duties on governing bodies and local authorities to provide data to local authorities and Welsh Ministers, respectively, on teacher assessment and national test outcomes for the pupils registered at schools in the 2020/21 school year. The Welsh Government will not be reporting on 2020/21 school performance measures, including them in All Wales Core Data Sets ('data packs'), or publishing them on the My Local School website. We will, however, need to retain provision that allows Welsh Government to receive results of approved qualifications, for other purposes not related to school performance or accountability.

Related policy amendments

11. Given the impact of disruption to school operations and cancellation of summer GCSE, AS and A level examinations, as in 2019/20, normal arrangements for the reporting of school performance outcomes for the 2020/21 academic year will be suspended. The Welsh Government will again be suspending the inclusion of performance measures in the All Wales Core Data Sets for schools and local authorities, Summary of Secondary School Performance, and relevant aspects of the My Local School website. Qualification awards data will not be used to report on attainment outcomes at a school, local authority or regional consortium level and must not be used to hold schools to account for their learners' outcomes.
