We want everyone in Wales to have a safe home and a good life. We all need to work together to make this happen.



The Ending Homelessness **Outcomes Framework** is a way of showing if we are making progress in different areas to end homelessness.



It is a difficult **framework** to understand, but we would like to know what you think. 2








The **framework** is set out like this:

Our goal is to end homelessness.

We will check this to see if we are reaching our goals by looking at:

- How many people have been helped to stay in their home.
- How many people are homeless.
- How many people are homeless and living on the streets.
- How many people have been helped to find a new home.



These things will tell us if we are doing well:

- The number of people helped to stay in their home will go up.
- The number of people who are homeless will go down.
- The number of people who are homeless and living on the streets will go down.
- The number of people helped to find a new home will go up.

The Welsh Government wrote a document to plan out how to end homelessness.



Homelessness means that a person does not have a place to call their home. This can be a **very** difficult situation for a person to be in.



The Welsh Government plan to end homelessness is called: the <u>Ending Homelessness Action Plan</u>.



The Ending Homelessness Action plan said we should develop an Ending Homelessness Outcomes Framework so we can all work together to end homelessness.



People from different organisations have worked on the Ending Homelessness **Outcomes Framework**.



They have shared their ideas to help create the Ending Homelessness **Outcomes Framework**.

How will the Framework be used?



We will use numbers about things like how many people have been helped to find a home.



This will show us how well we are doing in ending homelessness.



The Ending Homelessness **Outcomes Framework** means we can look at this progress all in one place.



It will show how close we are to reaching our goal of ending homelessness in Wales.



The Ending Homelessness **Outcomes Framework** will change over time to make sure it includes up to date information.



What will the Framework look like?

The Ending Homelessness **Outcomes Framework** Focuses on 6 main ways to end homelessness:

- 1. **Rare:** This means homelessness does not happen much. People are stopped from becoming homeless as quickly as possible.
- 2. **Brief:** This means for a short amount of time. People are helped quickly if they experience homelessness.
- 3. **Unrepeated:** This means it does not happen more than once. People are not homeless more than once in their life.
- 4. **Workforce:** A workforce is the people who work for an organisation. We want a good strong workforce with great skills to support people who are homeless.
- 5. **Public Service response:** This means an organisation that supports people in our communities. Public Services should be able to make sure the person feels safe and has the support they need.
- 6. **Person-centred approach:** This means putting the person at the centre of all decisions. People are treated equally in a way that suits them.
