We are the **Early Years, Childcare and Play Division** of the Welsh Government.



It helps children aged 0 to 5 with their speech, language and communication.

- **Speech** means how we say words.
- **Language** means the words we understand and use.
- **Communication** means sharing ideas, feelings and needs with others.



This programme has worked well over the last 5 years.



We now want to include children aged **5 to 11**.



This new plan is called **Talk with Me Phase 2**. The plan is for 2026 to 2030.

About the new plan



1 in 5 children and young people have difficulties with speech, language and communication.



More than 1 in 10 have long-term needs. These affect their learning.



Around 3 in 10 of these children live in areas where families have less money and support.



Children in these areas are more likely to develop language more slowly.



Speech, language and communication affect many other parts of life, like learning and mental health.



Supporting children gives big benefits and does not cost much money.



This new plan is to make sure more children in Wales get the support they need.

1. Tell more people about speech, language and communication



We want more families to understand why speech, language and communication are important.



We want families to know where and how to get support.

We will carry on:



- Running our campaign for children aged 0 to 5. We will focus on certain areas. For example, children in care.



- Working with Public Health Wales and others to make sure these issues are understood.

Some new things we will do are:



- Run a campaign to help people understand speech, language and communication development in children aged 5 to 11.



- Share clear information with staff through **Curriculum for Wales** resources.



- Share advice about screens and technology and how they affect communication.

We will carry on:



- Updating the early years speech, language and communication training framework. This framework is a document that describes what training is available in Wales.



- Sharing the training framework for school aged children.



- Giving training for Health Visitors and those who support their work.



- Making sure more people know about the information and support we have.

Some new things we will do are:



- Look at ways to train more staff. For example, Health Visitors, Teachers and Social Workers.



- Work with Care Inspectorate Wales and Estyn to make training and information that supports them.



- Make online training for staff who work with children aged 5 to 11.



- Learn from other countries about what works well.

- Supporting children's rights.



- Following advice about the best ways to work.



- Checking and updating speech, language and communication advice for Flying Start.



- Checking Talk with Me work.



- Supporting services to put speech, language and communication support in place.

Some new things we will do are:



- Work more closely with mental health services. This will help make sure speech, language and communication needs are understood.



- Work more closely with Additional Learning Needs services. This will help us understand their training needs.



- Work with staff who support children with reading and writing. Making sure they understand more about speech, language and communication.



- Work more closely with justice services, that help people with the law. This will help make sure people working in justice services understand speech, language and communication.
