Criteria	Weighting (W)
Strategic case: does the scheme demonstrate a sound case for change? Does it fit with the grant purpose/ objectives?	10
Well-being: Does the scheme align with and support <a href="#">Llwybr Newydd: the Wales transport strategy</a> ambitions? Does it maximise contribution to well-being? Does it offer value for money?	5
Management case: is the scheme deliverable and have any milestones been explained? Have the delivery risks been identified and mitigated?	5
Affordability: what is the total scheme cost to Local Transport Fund, Resilient Roads Fund and Ultra Low Emission Vehicle Transformation Fund?	4

- £0.2m-£0.49m = 4
- £0.5m-£0.99m = 3
- £1m-£4.99m = 2
- £5m-£9.99m = 1
- £10m and over = 0
