### Item 1 - Welcome, apologies and introductions

1.2 BC circulated his report to members ahead of the meeting to highlight the recent work. BC noted the encouragement from Ministers.

## <u>Item 3 – Update from Welsh Government</u>

- 3.1 AJ updated the group that Paul Neave who is a member of the core group of the NAN has been appointed as the new Head of Advice Services on Secondment to the Welsh Government. Paul will take up his new post on Monday 8<sup>th</sup> May 2017. The group welcomed this.
- 3.2 AJ informed the group that the Welsh Government responded to the joint HMT and DWP consultation on establishing a Single Financial Guidance Body (SFGB). The response set out that, subject to further discussion, Welsh Government was in favour of an alternative model of devolved responsibility and budgets in respect of the MAS elements of the proposed SFGB. This was also subject to a fair funding formula, which fully reflects the additional needs of people in Wales. This would then be implemented in line with the Financial Inclusion Delivery Plan and the Information and Advice Action Plan, published in December 2016, which supported an integrated funding model for holistic advice to include both preventative measures, such as financial capability, and crisis help. This approach would ensure best value for the money spent and full integration with other related activities.

Following this, HMT and DWP are currently preparing legislation and have shared a copy of the early draft bill with the Welsh Government, and engagement will continue at Official level.

3.3 AJ informed the group about the workshop held jointly between the Money Advice Service (MAS) and Welsh Government earlier that week. MAS are beginning their work on a new commissioning programme for debt advice services and also the Communities Division in Welsh Government are considering how the three separate advice services grants/programmes it funds can be better integrated. MAS & Welsh Government are looking at working closer together and also using the understanding and knowledge of the sector in shaping the direction of travel. The timescales are very tight with the analysis, planning and engagement stage during May and June, with the intention to share initial options with the Cabinet Secretary for Communities and Children by end of June.

# <u>Item 4 – Review of Welsh Government's Information and Advice Action</u> Plan

4.1 Action 14 of the Information and Advice Action Plan is for the National Advice Network to monitor delivery against the action plan and report to the Cabinet Secretary for Communities and Children on emerging priorities annually. For this exercise the group split into 3 groups each discussing the 'Quality', 'Funding' and 'Collaboration' actions in turn and the notes of the discussions can be found at Doc 1.

### Item 5 – NAN Work Plan
