**The Directions to Local Health Boards as to the Personal Dental
Services Statement of Financial Entitlements (Amendment)
Directions 2018**

Made - - - - 20 November 2018

Coming into force - - 21 November 2018

The Welsh Ministers in exercise of the powers conferred on them by sections 66(4) and (5), 203(9) and (10), and 204(1) of the National Health Service (Wales) Act 2006⁽¹⁾, give the following Directions:

Title and commencement

1.—(1) The title of these Directions is the Directions to Local Health Boards as to the Personal Dental Services Statement of Financial Entitlements (Amendment) Directions 2018.

(2) These Directions come into force on 21 November 2018 but have effect from 1 April 2018⁽²⁾.

Amendments to the Personal Dental Services Statement of Financial Entitlements

2. The Directions given by the Welsh Ministers to Local Health Boards as to the Personal Dental Services Statement of Financial Entitlements⁽³⁾, which came into force on 24 April 2009 are amended as follows.

Amendment of Section 2

3. In section 2 (negotiated annual agreement values) for paragraph 2.10 substitute:—

“2.10 The percentage determined by the Welsh Ministers for the financial year commencing on 1 April 2018 is 2.77%”.

Amendment of Section 7

4.—(1) Section 7 (payments in respect of vocational training), is amended as follows—

(2) Section 66(5) of the National Health (Wales) Act 2006 permits the retrospective effect of Directions given under s.60 of that Act provided such provision is not detrimental to the persons to whose remuneration it relates.

- (a) in paragraph 7.2(c) (eligibility for payments in respect of vocational training), for “£2,587”, substitute “£2,639”;
- (b) in paragraph 7.4(c) (applications for payments under this section), for “£2,587”, substitute “£2,639”; and
- (c) in paragraph 7.5 (vocational training payments to be made)—
 - (i) in sub-paragraph (a), for “£863.51” substitute “£881.00”;
 - (ii) in sub-paragraph (b), for “£2,587”, substitute “£2,639”; and
 - (iii) in sub-paragraph (d), for “£5,096”, substitute “£5,237”.
