1. Daw'r Gorchymyn hwn i rym ar 12 Ionawr 2017. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A483 (Stryd Rhosmaen, Llandeilo, Sir Gaerfyrddin) (Terfyn Cyflymder 20 myna Llawnamser a Rhan-amser) 2017.

The A483 Trunk Road (Rhosmaen Street, Llandeilo, Carmarthenshire) (Full & Part-Time 20 mph Speed Limit) Order 2017

The Welsh Ministers, as traffic authority for the Swansea - Manchester Trunk Road (A483) (“the trunk road”), in exercise of the powers conferred upon them by sections 84(1), (1A) and (2) of the Road Traffic Regulation Act 1984⁽¹⁾ (“the 1984 Act”) and after consultation with the Chief Officer of the Dyfed-Powys Police, make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 12 January 2017. Its title is The A483 Trunk Road (Rhosmaen Street, Llandeilo, Carmarthenshire) (Full & Part-Time 20 mph Speed Limit) Order 2017.

2. In this Order:

“exempted vehicle” (“cerbyd esempt”) means:

(a) any vehicle being used by the emergency services for the purposes described in section 87 of the 1984 Act⁽²⁾;

(b) unrhyw gerbyd sy'n cael ei ddefnyddio at ddibenion y llynges, y fyddin neu'r llu awyr ac sy'n cael ei yrru gan berson sydd am y tro yn ddarostyngedig i orchymynion aelod o luoedd arfog y Goron, sy'n aelod o'r luoedd arbennig—

- (i) ac sydd wedi ei hyfforddi i yrru ar gyflymderau uchel ac sy'n gweithredu wrth ymateb, neu wrth ymarfer ymateb, i argyfwng diogelwch gwladol; neu
- (ii) at ddiben hyfforddi person i yrru cerbydau ar gyflymderau uchel.

ystyr “y darnau o'r gefnffordd” (“*the lengths of the trunk road*”) yw'r darnau hynny o'r gefnffordd yn Llandeilo yn Sir Gaerfyrddin a ddisgrifir yn yr Atodleni i'r Gorchymyn hwn;

ystyr “lluoedd arbennig” (“*special forces*”) yw'r unedau hynny o'r luoedd cartref y mae Cyfarwyddwr y Lluoedd Arbennig yn gyfrifol am gynnal eu galluoedd neu sydd am y tro yn ddarostyngedig i reolaeth weithredol y Cyfarwyddwr hwnnw.

Cyfyngiad

3. Ni chaiff neb yrru unrhyw gerbyd, ac eithrio cerbyd esempt, yn gyflymach nag 20 milltir yr awr ar y darn o'r gefnffordd a bennir yn Atodlen 1.

4. Ni chaiff neb yrru unrhyw gerbyd, ac eithrio cerbyd esempt, yn gyflymach nag 20 milltir yr awr ar y darn o'r gefnffordd a bennir yn Atodlen 2.

Cymhwysyo

5. Ni fydd darpariaeth erthygl 4 yn gymwys ond ar yr adegau hynny ac i'r graddau hynny y bydd arwyddion traffig yn dangos bod y cyfyngiad y mae'n cyfeirio ato yn weithredol.

(b) any vehicle being used for naval, military or air force purposes and are being driven by a person for the time being subject to the orders of the member of the armed forces of the Crown, who is a member of the special forces—

- (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
- (ii) for the purpose of training a person in driving vehicles at high speeds.

“the lengths of the trunk road” (“y darnau o'r gefnffordd”) means those lengths of the trunk road at Llandeilo in Carmathenshire specified in the Schedules to this Order;

“special forces” (“lluoedd arbennig”) means those units of the home forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director.

Restriction

3. No person shall drive any vehicle, other than an exempted vehicle, at a speed exceeding 20 miles per hour on the length of the trunk road specified in Schedule 1.

4. No person shall drive any vehicle, other than an exempted vehicle, at a speed exceeding 20 miles per hour on the length of the trunk road specified in Schedule 2.

Application

5. The provision of article 4 applies only during such times and to such extent as the application of the restriction referred to therein is indicated by means of traffic signs.

Full-Time 20 MPH Speed Limit

The length of the trunk road known as Rhosmaen Street, Llandeilo, Carmarthenshire that extends from a point 105 metres north of the centre-point of its junction with Church Street to a point 30 metres north east of the centre-point of its junction with New Road.

SCHEDULE 2

Part-Time 20 MPH Speed Limit

The length of the trunk road known as Rhosmaen Street, Llandeilo, Carmarthenshire that extends from a point 30 metres north east of the centre-point of its junction with New Road to a point 78 metres south of the centre-point of its junction with Station Road.

THE A483 TRUNK ROAD (RHOSMAEN STREET, LLANDEILO, CARMARTHENSIRE) (FULL & PART-TIME 20 MPH SPEED LIMIT) ORDER 2017

The Welsh Ministers have made an Order in exercise of their powers under section 84(1), 1(A) and (2) of the Road Traffic Regulation Act 1984, which comes into force on 12 January 2017.

The effect of the Order will be to impose a 20 mph speed limit on the length of the A483 trunk road described in Schedule 1 to this Notice. A part-time 20 mph speed limit will also be imposed on the length of the A483 trunk road described in Schedule 2 to this Notice in order to minimise the likelihood of danger to the public in connection with pedestrian movements near Ysgol Gymraeg Teilo Sant and Ysgol Gynradd Llandeilo Primary School at Llandeilo, Carmarthenshire. The part-time 20 mph speed limit is only expected to apply for limited periods of the day during school term time and at all other times the existing 30 mph speed limit will remain in force.
