The A494 Trunk Road
(Queensferry, Flintshire)
(Prohibition of Pedestrians) Order
2016

Coming into force 30 June 2016

Title, Interpretation and Commencement

2. (1) In this Order –

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

3. Except as provided in article 4, no person shall, except upon the direction or with the permission of a police constable, police community support officer or civil enforcement officer, proceed along the lengths of the trunk road.

Exemptions

4. Nothing in article 3 shall render it unlawful for a pedestrian to proceed in the lengths of the trunk road where:

(a) it is necessary to do so to avoid or prevent an accident or to obtain or give help as a result of an accident or emergency and the pedestrian does so in such a manner as to cause as little danger or inconvenience as possible to other traffic on the trunk road;

(b) the pedestrian does so in exercise of his or her duty as a police constable, police community support officer, civil enforcement officer or as a member of the emergency services;

(c) it is necessary to do so in order to recover or move an object that has fallen onto the trunk road;

(d) it is necessary to do so in order to carry out in an efficient manner:

(i) the maintenance, repair, cleaning, clearance, alteration or improvement of any part of the trunk road;

(ii) the removal of any vehicle from any part of the trunk road; or

(iii) the erection, laying, placing, maintenance, testing, alteration, repair or removal of any structure, works or apparatus in, on, under, over or abutting any part of the trunk road;

(e) where it is necessary to do so in connection with any inspection, survey, investigation or census that relates to the trunk road or any part thereof and which is carried out in accordance with any general or special authority granted by the Welsh Ministers.

(1) 1984 c.27; sections 1(1), 2(1) and (2) were amended by the New Roads and Street Works Act 1991 (c.22), section 168 and Schedule 8, paragraphs 17 and 18. THE A494 TRUNK ROAD (QUEENSFERRY, FLINTSHIRE) (PROHIBITION OF PEDESTRIANS) ORDER 2016

The Welsh Ministers have made an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984, which comes into force on the 30 June 2016.

The effect of the Order will be to prohibit pedestrians along lengths of the A494 trunk road at Queensferry in the County of Flintshire as specified in the Schedule to this Notice,

During a period of 6 weeks from 30 June 2016, a copy of the Order and plan may be inspected during normal office hours at Queensferry Library, Queensferry Campus, Queensferry, Flintshire CH5 1SE or may be obtained free of charge from the address below quoting reference number qA122201.

If any person desires to question the validity of the Order, or of any provisions contained therein on the grounds:

- a. that it is not within the relevant powers of the Road Traffic Regulation Act 1984; or
- b. that any of the relevant requirements has not been complied with,

that person may, within 6 weeks of 29 June 2016, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
