**The A487 Trunk Road
(Pwllgoleulas, Gwynedd) (40 mph
Speed Limit) Order 2016**

Made 27 January 2016

Coming into force 29 January 2016

The Welsh Ministers, as traffic authority for the Fishguard – Bangor Trunk Road (A487) (“the trunk road”), in exercise of the powers conferred upon them by sections 84(1), (2) and 124(1)(d) of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984(1) and after consultation with the Chief Officer of the North Wales Police, make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 29 January 2016 and its title is The A487 Trunk Road (Pwllgoleulas, Gwynedd) (40 mph Speed Limit) Order 2016.

2. In this Order:

“exempted vehicle” (“*cerbyd esempt*”) means:

(a) any vehicle being used by the emergency services for the purposes described in section 87 of the Road Traffic Regulation Act 1984(2);

(b) any vehicle being used for naval, military or air force purposes and are being driven by a person for the time being subject to the orders of the member of the armed forces of the Crown, who is a member of the special forces—

- (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
- (ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director.

Restriction

3. No person shall drive any vehicle, other than an exempted vehicle, at a speed exceeding 40 miles per hour in the length of the trunk road that extends in a north-westerly direction from a point 162 metres south-east of the centre-point of its junction with the road leading to Ysbyty Alltwen near Tremadog, Gwynedd to a point 555 metres north-west of the centre-point of the said junction.

Revocation

4. The A487 Trunk Road (Tremadog, Gwynedd) (40 mph Speed Limit) Order 2006(3) and The A487 Trunk Road (Tremadog, Gwynedd) (40 MPH Speed Limit) Order 2006 (Variation) Order 2007(4) are hereby revoked.

**THE A487 TRUNK ROAD (PWLLGOLEULAS,
GWYNEDD) (40 MPH SPEED LIMIT) ORDER
2016**

The Welsh Ministers have made an Order under sections 84(1), (2) and 124(1)(d) of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984, which comes into force on 29 January 2016.

The effect of the Order is to impose a 40 mph speed limit on the length of the A487 trunk road at Pwllgoleulas, Gwynedd that extends in a north-westerly direction from a point 162 metres south-east of the centre-point of its junction with the road leading to Ysbyty Alltwen, near Tremadog to a point 555 metres north-west of the centre-point of the said junction.

The Order is required in the interests of road safety. A 40 mph speed limit is currently in place at this location but due to changes in road layout following the construction of the Porthmadog Bypass and the relocation of signs the existing Order will be revoked and replaced with this new Order to ensure the extents of the restriction are accurate and that enforcement of the speed restriction is not compromised.
