**1.** (1) Enw'r Gorchymyn hwn yw Gorchymyn Cau Priffyrd (Ffordd Watkiss, Bae Caerdydd, Caerdydd) 2017.

(2) Yn y Gorchymyn hwn:-

ystyr “y Cyngor” (“*the Council*”) yw Cyngor Dinas a Sir Caerdydd;

ystyr “y datblygwr” (“*the developer*”) yw'r person sy'n gwneud y datblygiad y mae'r caniatâd cynllunio wedi ei roi ar ei gyfer;

ystyr “Deddf 1990” (“*the 1990 Act*”) yw Deddf Cynllunio Gwlad a Thref 1990;

ystyr “y plan a adneuwyd” (“*the deposited plan*”) yw'r plan sy'n dwyn yr enw “Gorchymyn Cau Priffyrd (Ffordd Watkiss, Bae Caerdydd, Caerdydd) 2017” sy'n dod gyda'r Gorchymyn hwn.

The Welsh Ministers make this Order in exercise of their powers under section 247 of the Town and Country Planning Act 1990(1).

**Title, Interpretation and Commencement**

**1.** (1) The title of this Order is The Stopping Up of Highways (Watkiss Way, Cardiff Bay, Cardiff) Order 2017.

(2) In this Order:-

“the Council” (“*y Cyngor*”) means the Council of the City and County of Cardiff;

“the deposited plan” (“*y plan a adneuwyd*”) means the plan entitled “The Stopping Up of Highways (Watkiss Way, Cardiff Bay, Cardiff) Order 2017” which accompanies this Order;

“the developer” (“*y datblygwr*”) means the person carrying out the development for which the planning permission has been given;

“the 1990 Act” (“*Y Deddf 1990*”) means the Town and Country Planning Act 1990.

(3) This Order comes into force on the date on which notice that it has been made is published in accordance with section 252(10) of the 1990 Act.

Yn rhinwedd erthygl 2 o O.S. 1999/672, ac Atodlen 1 iddo, trosglwyddwyd swyddogaethau'r Ysgrifennyyd Gwladol, i'r graddau yr oeddent yn arferadwy o ran Cymru, i Gynulliad Cenedlaethol Cymru ac maent yn arferadwy bellach gan Weinidogion Cymru yn rhinwedd adran 162 o Ddeddf Llywodraeth Cymru 2006 a pharagraff 30(2) o Atodlen 11 iddi.

## Cau Prifordd

2. Yn ddarostyngedig i erthyglau 3, 4, 5 a 6 o'r Gorchymyn hwn, mae Gweinidogion Cymru yn awdurdodi cau'r darn o briffordd a ddisgrifir yn Atodlen 1 ac a ddangosir â llinellau sebra ar y plan a adneuwyd. Mae Gweinidogion Cymru wedi eu bodloni bod angen cau'r briffordd er mwyn gwneud y datblygiad yn unol â'r caniatâd cynllunio a roddwyd o dan Ran 3 o Ddeddf 1990 gan y Cyngor ar 29 Medi 2010 o dan y cyfeirnod 08/02191/C; ar 8 Awst 2014 o dan y cyfeirnodau 13/00310/DCI, 13/01631/DCI ac 13/02547/DCI, ac ar 26 Mai 2016 o dan y cyfeirnod 15/01463/MJR ac a ddisgrifir yn Atodlen 3 i'r Gorchymyn hwn.

## Prifordd Newydd

3. Rhaid creu, er boddhad rhesymol y Cyngor, y darn newydd o briffordd a ddisgrifir yn Atodlen 2 i'r Gorchymyn hwn, ac a ddangosir â dotwaith ar y plan a adneuwyd, sy'n briffordd sydd, at ddibenion Deddf Prifyrdd 1980(2), i'w chynnal a'i chadw ar draul y pwrs cyhoeddus. Y Cyngor fydd yr awdurdod prifyrdd ar ei chyfer.

## Y Darpariaethau sy'n Angenrheidiol neu'n Hwylus cyn Cau Prifordd ac ar gyfer Darparu'r Briffordd

4. Ni chaniateir cau'r darn o briffordd a ddisgrifir yn Atodlen 1:-

- (a) hyd nes y bydd y datblygwr wedi darparu, er boddhad rhesymol y Cyngor, blaniau sy'n dangos sut y mae'r darn o'r briffordd a ddisgrifir yn Atodlen 1 i'w gau;
- (b) hyd nes y bydd y datblygwr wedi darparu'r briffordd newydd a ddisgrifir yn Atodlen 2 i'r Gorchymyn hwn er boddhad rhesymol y Cyngor;
- (c) hyd nes y bydd y datblygiad a ddisgrifir yn Atodlen 3 wedi ei ddechrau a bod y datblygwr wedi hysbysu'r Cyngor yn ysgrifenedig ei bod yn angenrheidiol cau'r briffordd a ddisgrifir yn Atodlen 1 er mwyn i'r datblygiad fynd rhagddo; a
- (d) hyd nes y bydd y Cyngor wedi ysgrifennu at y datblygwr i gadarnhau bod paragraffau (a), (b) ac (c) wedi eu bodloni.

## Stopping Up

2. Subject to articles 3, 4, 5 and 6 of this Order the Welsh Ministers authorise the stopping up of the length of highway described in Schedule 1 shown by zebra hatching on the deposited plan. The Welsh Ministers are satisfied that the stopping up is necessary to enable development to be carried out in accordance with planning permission granted under Part 3 of the 1990 Act by the Council on 29 September 2010 under reference number 08/02191/C; on 8 August 2014 under reference numbers 13/00310/DCI, 13/01631/DCI and 13/02547/DCI, and on 26 May 2016 under reference 15/01463/MJR and described in Schedule 3 to this Order.

## New Highway

3. There must be created, to the reasonable satisfaction of the Council, the new length of highway described in Schedule 2 to this Order and shown by stipple marking on the deposited plan, which is to be highway which, for the purposes of the Highways Act 1980(2) is highway maintainable at the public expense and the Council will be the highway authority responsible for it.

## Provisions Necessary or Expedient before Stopping Up and for the Provision of the Highway

4. The length of highway described in Schedule 1 must not be stopped up until:-

- (a) the developer has provided, to the reasonable satisfaction of the Council, plans showing the length of highway described in Schedule 1 are to be stopped up;
- (b) the developer has provided the new highway as described in Schedule 2 to this Order to the reasonable satisfaction of the Council;
- (c) the development described in Schedule 3 has commenced and the developer has informed the Council in writing of the necessity to stop up the highway described in Schedule 1 to allow the development to proceed; and
- (d) the Council has confirmed in writing to the developer that paragraphs (a), (b) and (c) are satisfied.

## **Ymgwymerwyr Statudol a Darparwyr**

**5.** Pan fo gan ymgwymerwyr statudol neu ddarparwyr system gyfathrebu gyhoeddus unrhyw gyfarpar o dan y briffordd, ynddi, arni, drosti, ar ei hyd neu ar ei thraws yn union cyn cau'r darn o briffordd yna (yn ddarostyngedig i adran 261(4) o Ddeddf 1990), bydd gan yr ymgwymerwyr neu'r darparwyr yr un hawliau mewn cysylltiad â'r cyfarpar ag a oedd ganddynt cyn cau'r briffordd.

## **Cyfnod Para'r Gorchymyn hwn**

**6.** Os na fydd y datblygiad a ddisgrifir yn Atodlen 3 wedi ei ddechrau yn y cyfnod perthnasol a bennir yn Rhan 3 o Ddeddf 1990 fel cyfnod para'r caniatâd cynllunio, neu os caiff y caniatâd ei ddirymu cyn diwedd y cyfnod hwnnw, bydd y Gorchymyn hwn yn peidio â chael effaith pan ddaw'r caniatâd cynllunio i ben.

**5.** Where immediately before the length of highway is to be stopped up, there is under, in, on, over, along or across the highway any apparatus of statutory undertakers or public communications providers then (subject to section 261(4) of the 1990 Act) the undertakers or providers continue to have the same rights in respect of the apparatus as they had before the stopping up.

## **Duration of this Order**

**6.** If the development described in Schedule 3 has not begun within the relevant period specified in Part 3 of the 1990 Act as being the duration of the planning permission, or the permission is revoked before the end of such period, this Order ceases to have effect upon the cessation of the planning permission.

## TOWN AND COUNTRY PLANNING ACT 1990

### **THE STOPPING UP OF HIGHWAYS (WATKISS WAY, CARDIFF BAY, CARDIFF) ORDER 2017**

The Welsh Ministers have made an Order under section 247 of the Town and Country Planning Act 1990, to authorise the stopping up of the length of highway described in Schedule 1 to this Notice and to construct the new length of highway described in Schedule 2 to this Notice to enable the development described in Schedule 3 to be carried out. The Stopping Up of Highways (Watkiss Way, Cardiff Bay, Cardiff) Order 2015 ("the Order") will cease to have effect if planning permission in respect of the development expires or is revoked.

If a person is aggrieved by the Order, on the ground that:

that person may, within 6 weeks of 13 January 2017 make an application for the purpose to the High Court.
