TOWN AND COUNTRY PLANNING ACT 1990

THE STOPPING UP OF HIGHWAYS (DICKIES BOAT YARD, LON GLANDWR, BANGOR, GWYNEDD) ORDER 2012

Made 17 April 2012

Coming into force 26 April 2012

The Welsh Ministers make this Order in exercise of their powers under section 247 of the Town and Country Planning Act 1990 (1) (hereinafter referred to as "the Act of 1990") and of all other enabling powers (2).

1. In this Order: -

"the Council" ("y Cyngor") means Gwynedd Council;

"the developer" ("y datblygwr") means the person carrying out the development for which the planning permission referred to below has been given;

"the deposited plan" ("y plan a adneuwyd") means the plan entitled "The Stopping Up of Highways (Dickies Boat Yard, Lon Glandwr, Bangor, Gwynedd) Order 2012" which accompanies this Order.

- **2.** Subject to the provisions of articles 3, 4, 5 and 6 of this Order, the Welsh Ministers authorise the stopping up of the area of highway described in Schedule 1 to this Order and shown with zebra hatched lines on the deposited map, being satisfied that the stopping up is necessary to enable the development described in Schedule 4 to this Order to be carried out in accordance with planning permission granted under Part III of the Act of 1990 by the Council on 6 January 2012 under reference C09A/0410/11/LL.
- 3. There shall be created, to the reasonable satisfaction of the Council, the new highway described in Schedule 2 to this Order and shown by stipple marking on the deposited plan and the improved highway described in Schedule 3 to this Order and shown by cross hatching on the deposited plan, which are to be highways which, for the purposes of the Highway Act 1980(3), are to be highways maintainable at the public expense and the Council is to be the highway authority for them.

- **4.** The area of highway described in Schedule 1 to this Order may not be stopped up until:
- (a) the developer has provided, to the reasonable satisfaction of the Council, plans showing the means whereby the areas of highway are to be stopped up;
- (b) the developer has provided the new highways described in Schedule 2 to this Order to the reasonable satisfaction of the Council;
- (c) the development referred to in Schedule 4 of this Order has commenced and the developer has informed the Council in writing of the necessity to close the areas of highway to allow the development to proceed; and
- (d) the Council has confirmed in writing to the developer that the provisions of (a), (b) and (c) of this article have been fulfilled.
- 5. Where immediately before the area of highway is stopped up in pursuance of this Order there is under, in, on, over, along or across that highway any apparatus of statutory undertakers or public communications providers then, (subject to section 261(4) of the Act of 1990), the undertakers or providers are to continue to have the same rights in respect of the apparatus as they had before the stopping up.
- **6.** If the development referred to in Schedule 4 of this Order has not begun within the relevant period specified in Part III of the Act of 1990 as being the duration of the planning permission or the permission is revoked before the end of such period, this Order will cease to have effect upon cessation of the planning permission.
- 7. This Order will come into operation on the date on which notice that it has been made is first published in accordance with section 252 (10) of the Act of 1990. The title to this Order is The Stopping Up of Highways (Dickies Boat Yard, Lon Glandwr, Bangor, Gwynedd) Order 2012.

<u>Description of the area of highway to be improved under this Order</u>

A rectangular shaped area forming part of the highway known as Lon Glandwr, having a maximum length of 32.6 metres, a maximum width of 2.5 metres and a total area of 81.5 square metres. The area extends from point C to point D on the deposited plan.

NOTICE IS HEREBY GIVEN that the Welsh Ministers have made an Order under section 247 of the Town and Country Planning Act 1990 to authorise the stopping up of the area of highway described in Schedule 1 to this Notice; to provide for the new area of highway described in Schedule 2 to this Notice and to improve the area of highway described in Schedule 3 to this Notice.

The stopping up will be authorised only in order to enable the development described in Schedule 4 of this Notice to be carried out. The Order will cease to have effect if the planning permission expires or is revoked.

During the 6 weeks from 26 April 2012, copies of the Order and the deposited map may be inspected free of charge at the offices of the Bangor City Council, Town Hall, Bangor, Gwynedd LL57 1DT or may be obtained free of charge from the address below quoting the Welsh Government reference qA990863.

If any person desires to question the validity of the Order, or of any of the provisions contained therein, on the grounds:

- a. that it is not within the powers of the Town and Country Planning Act 1990; or
- b. that their interests have been substantially prejudiced by a failure to comply with any requirements of the Act,

that person may, within 6 weeks of 26 April 2012, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
