

## ACQUISITION OF LAND ACT 1981

**NOTICE OF A PROPOSED COMPULSORY PURCHASE OF LAND FORMING PART OF A COMMON, SUCH LAND BEING KNOWN AS GELLIGAER AND MERTHYR COMMON (PART OF REGISTER UNIT CL38) IN THE COUNTY BOROUGH OF MERTHYR TYDFIL**

**THE WELSH MINISTERS (THE NEATH TO ABERGAVENNY TRUNK ROAD (A465) (ABERGAVENNY TO HIRWAUN DUALLING AND SLIP ROADS) AND EAST OF ABERCYNON TO EAST OF DOWLAIS TRUNK ROAD (A4060) AND CARDIFF TO GLAN CONWY TRUNK ROAD (A470) (CONNECTING ROADS) (DOWLAIS TOP TO HIRWAUN)) COMPULSORY PURCHASE ORDER 2019**

The Welsh Ministers have decided to make the above-named draft compulsory purchase order which will authorise the compulsory acquisition of land which forms part of a common, within the meaning of the Acquisition of Land Act 1981.

The land to be acquired is described in the Schedule below, with the area of land which forms part of a common shown coloured pink on the Map annexed to this certificate.

The Welsh Ministers **HEREBY CERTIFY**, in exercise of their powers under Section 19 of the Acquisition of Land Act 1981, they are satisfied that as regards the acquisition of land,

(a) as regards the purchase of land forming part of a common

“that the land does not exceed 250 square yards in extent or is required for the widening or drainage of an existing highway or partly for the widening and partly for the drainage of such a highway and that the giving in exchange of other land is unnecessary, whether in the interests of the persons, if any, entitled to rights of common or other rights or in the interests of the persons, if any, entitled to rights of common or other rights or in the interests of the public”.
