NATIONAL HEALTH SERVICE ACT 1977

DIRECTIONS TO LOCAL HEALTH BOARDS AND NHS TRUSTS IN WALES 2006

Made 25 October 2006

Coming into force 26 October 2006

The National Assembly for Wales, in exercise of the powers conferred by sections 16BB(4), 17(1), 97F(8) and 126(4) of the National Health Service Act 1977(1) hereby gives the following directions —

Commencement, application and interpretation

- 1.—(1) These Directions come into force on 26 October 2006 and apply to every Local Health Board and NHS trust in Wales.
 - (2) These Directions apply in relation to Wales.
 - (3) In these Directions
 - "the Principal Directions" ("y Prif Gyfarwyddiadau") means the Directions to Local Health Boards and NHS trusts in Wales concerning Arrangements for the Funding of Technology Appraisal Guidance from the National Institute for Clinical Excellence (NICE) dated 23 October 2003(2).
 - (4) These Directions amend the Principal Directions.

 Appraisal Guidance (No. 102) on
 parent—training/education
 programmes in the management of
 children with conduct disorders
 dated July 26 2006 paragraph 2 of
 these Directions applies except that
 the words "three months" will be
 replaced by the words "twenty four
 months"".
 - (2) In paragraph 3 insert as paragraph 3.(2)(g) "(g) the Technology Appraisal Guidance (No. 105) on laparoscopic surgery for colorectal cancer dated 23 August 2006".
