The Welsh Ministers in exercise of the powers conferred on them by sections 45, 203(9) and (10) and 204(1) of the National Health Service (Wales) Act 2006¹, and after consulting in accordance with section 45(4) of that Act with the bodies appearing to them to be representative of persons to whose remuneration these Directions relate, hereby give the following Directions:

Title, commencement and application

- 1. —(1) The title of these Directions is the Directions to Local Health Boards as to the Statement of Financial Entitlements (Amendment) Directions 2013.
 - (2) These Directions are given to Local Health Boards and apply in relation to Wales.
- (3) These Directions amend Part 2 and 3 of Annex G of the Directions to Local Health Boards as to the Statement of Financial Entitlements Directions 2013 ("the SFE"), which came into force on 11 June 2013.
- (4) The provisions of these Directions come into force as provided for in the following sub-paragraphs-
 - (a) direction 1, immediately after these Directions are signed;
 - (b) directions 2 and 4, on 1 October 2013; and
 - (c) directions 3 and 5, on 1 April 2014.
