**The Primary Medical Services (Directed Enhanced Services)  
(Wales) (Amendments) Directions 2015**

*25 June 2015*

*Coming into force in accordance with direction 1(2)*

The Welsh Ministers give the following directions in exercise of the powers conferred by sections 12(3), 45, 203(9) and (10) and 204(1) of the National Health Service (Wales) Act 2006<sup>(1)</sup>.

**Title, commencement and application**

**1.**—(1) The title of these Directions is the Primary Medical Services (Directed Enhanced Services) (Wales) (Amendments) Directions 2015.

(2) These Directions come into force on 26 June 2015 but have effect from 1 April 2015.

(3) These Directions are given to Local Health Boards and apply in relation to Wales.

**Amendments to the Primary Medical Services (Directed Enhanced Services) (Wales) (No. 2) Directions 2009**

**2.** The Primary Medical Services (Directed Enhanced Services) (Wales) (No. 2) Directions 2009 which came into force on 22 May 2009 are amended as follows:

- (a) in direction 4(2) (Extended Hours Access Scheme), in sub-paragraph (k)(i), for “£1.95”, substitute “£1.97”.
- (b) in direction 5 (Asylum Seeker and Refugee Scheme) —
  - (i) in sub-paragraph (i)(aa) of paragraph (1), for “£102.73”, substitute “£103.92”;
  - (ii) in sub-paragraph (i)(bb) of paragraph (1), for “£51.37”, substitute “£51.97”; and
  - (iii) in sub-paragraph (i)(cc) of paragraph (1), for “£51.37”, substitute “£51.97”.
- (c) in direction 6 (Homeless Scheme) —
  - (i) in sub-paragraph (i)(aa) of paragraph (1), for “£1,094.06”, substitute “£1,106.75”; and
  - (ii) in sub-paragraph (i)(bb) of paragraph (1), for “£108.90”, substitute “£110.16”.
- (d) in direction 7 (Care Homes Scheme), in sub-paragraph (i) of paragraph (o), for “£154.10”, substitute “£155.89”.
- (e) in direction 8 (Diabetes Care Scheme) —
  - (i) in sub-paragraph (i)(aa) of paragraph (i), for “£10.28”, substitute “£10.40”; and


- (ii) in sub-paragraph (i)(bb) of paragraph (i), for “£20.54”, substitute “£20.78”.

**Amendments to the Primary Medical Services (Directed Enhanced Services) (Wales) Directions 2007**

3. The Primary Medical Services (Directed Enhanced Services) (Wales) Directions 2007 which came into force on 12 December 2007 are amended as follows:

- (a) in direction 6 (Influenza and Pneumococcal Immunisation Scheme Plans) —
  - (i) for sub-paragraph (b)(i)(aa) and (bb) substitute –
    - “(aa) to make that offer during the period from 1 August to 31 March in that financial year and to concentrate the immunisation programme during the period from 1 September to 31 January in that financial year, but
    - (bb) where influenza is still circulating at 31 March, to continue to make that offer during the period from 1 April to 31 May, and”.
- (b) in direction 9(2) (Severe Mental Illness Scheme Plans), in sub-paragraph (g)(i), for “£100.55”, substitute “£101.72”.
- (c) in direction 10(2) (Learning Disabilities Scheme), in sub-paragraph (i)(i), for “£102.73”, substitute “£103.92”.
