Directions to Local Health Boards as to the Statement of Financial Entitlements (Amendment) (No. 2) Directions 2018

Made - - - - 19 November 2018

Coming into force in accordance with direction 1(3)

The Welsh Ministers in exercise of the powers conferred on them by sections 45, 203(9) and (10) and 204(1) of the National Health Service (Wales) Act 2006(a), and after consulting in accordance with section 45(4) of that Act with the bodies appearing to them to be representative of persons to whose remuneration these Directions relate, give the following Directions:

Title, application and commencement

- **1.**—(1) The title of these Directions is the Directions to Local Health Boards as to the Statement of Financial Entitlements (Amendment) (No. 2) Directions 2018.
 - (2) These Directions are given to Local Health Boards.
- (3) These Directions are made on 19 November 2018 and come into force on 20 November 2018. Paragraph 3 of these Directions have effect from 1 January 2019. Paragraph 4 of these Directions have effect from 1 April 2018 and paragraph 5 and 6 of these Directions have effect from 1 October 2018(**b**).

Amendments to the Statement of Financial Entitlements

2. The Directions to Local Health Boards as to the Statement of Financial Entitlements Directions 2013(c) which came into force on 11 June 2013, as amended by the Directions listed in Annex J at Schedule 1 to these Directions, are further amended.

Amendment of Section 2 – Global Sum Payments

3. In paragraph 2.3 for "1 April 2015" substitute "1 January 2019" and for "£86.17", substitute "£89.63" followed by "At the end of January 2019, a backdated Global Sum monthly payment of £3.46 is to be applied per weighted patient for the period from 1 April 2018 to 31 December 2018."

- (3) In paragraph 12.3(2)(b)(i) and (ii) for "locum" in each place where it appears, substitute "cover".
