## THE NATIONAL HEALTH SERVICE (WALES) ACT 2006

## Directions to Local Health Boards as to the Statement of Financial Entitlements (Amendment) (No. 2) Directions 2014

Made - - - 27 June 2014

*Coming into force in accordance with direction 1(3)* 

The Welsh Ministers in exercise of the powers conferred on them by sections 45, 203(9) and (10) and 204(1) of the National Health Service (Wales) Act 2006(1), and after consulting in accordance with section 45(4) of that Act with the bodies appearing to them to be representative of persons to whose remuneration these Directions relate, hereby give the following Directions:

#### Title, commencement and application

**1.**—(1) The title of these Directions is the Directions to Local Health Boards as to the Statement of Financial Entitlements (Amendment) (No. 2) Directions 2014.

- (2) These Directions are given to Local Health Boards and apply in relation to Wales.
- (3) These Directions come into force on 30 June 2014 but shall have effect from 1 April 2014.

#### Amendments to the Statement of Financial Entitlements

**2.** The Directions to Local Health Boards as to the Statement of Financial Entitlements(**2**) which came into force on 11 June 2013, as amended by the Directions listed in Annex J to these Directions, are further amended as follows.

#### Amendment to the Table of Contents

**3.** The Table of Contents is amended as follows:

- (a) in the Table of Contents in Part 1 Section 3 (Minimum Practice Income Guarantee), for the heading "Continuing Obligation to pay Correction Factor Monthly Payments in respect of the period ending on 31st March 2013", substitute "Continuing Obligation to pay Correction Factor Monthly Payments in respect of the period ending on 31st March 2014"; and
- (b) in the Table of Contents in Part 1 Section 3 (Minimum Practice Income Guarantee), after the heading "Review and revision of the baseline monthly figure amount for Correction Factor Monthly Payments in respect of the period 1<sup>st</sup> April 2013 and ending 31<sup>st</sup> March 2014", insert "Review and revision of the baseline monthly figure amount for Correction Factor Monthly Payments in respect of the period 1<sup>st</sup> April 2014 and ending 31<sup>st</sup> March 2015".

#### **4.** Section 3 (Minimum Practice Income Guarantee) is amended as follows:

(a) after paragraph 3.17, insert the following –

#### "Review and revision of the baseline monthly figure amount for Correction Factor Monthly Payments in respect of the period 1<sup>st</sup> April 2014 and ending 31<sup>st</sup> March 2015

3.17A. In respect of the period commencing on 1<sup>st</sup> April 2014 and ending on 31<sup>st</sup> March 2015, the LHB must review the baseline monthly figure amount in respect of a contractor's CFMP (which is the monthly figure for any CFMP that was payable at the end of the previous financial year) and uprate that amount by 4.8% which is the percentage by which the first amount specified in paragraph 2.3 is uprated for the start of the financial year"; and

(b) for paragraph 3.19, substitute –

"3.19 Except where paragraph 3.18 applies, in respect of the period commencing on 1<sup>st</sup> April 2014 and ending on 31<sup>st</sup> March 2015, the amount of a contractor's CFMP is to be the revised baseline monthly figure as calculated in accordance with paragraph 3.17A."
