# Directions to NHS Trusts and Powys Local Health Board 2006

Made 26 September 2006

Coming into force 27 September 2006

The National Assembly for Wales in exercise of the powers conferred by sections 16BB(4), 17(1) and 126(4) of the National Health Service Act 1977(a) gives the following directions:

#### PART I

#### **PRELIMINARY**

#### Commencement, application and interpretation

- **1.**—(1) These Directions come into force on 27<sup>th</sup> September 2006 and apply to every NHS Trust in Wales and Powys Local Health Board.
  - (2) These Directions apply in relation to Wales.
- (3) In these Directions unless the context otherwise requires "non-officer members" has the meaning assigned to it by regulation 2 of the Local Health Boards (Constitution, Membership and Procedures) (Wales) Regulations 2003(b).

#### **NHS Trusts**

- **2.** Each NHS Trust must nominate and publicise the nomination and identity of one of its non-executive directors to undertake the following:
  - (a) to act as a 'patient's champion' on issues relating to cleaning, hygiene and infection management, more particularly to:-
    - (i) communicate to appropriate Trust personnel relevant matters, including those which promote improvement, relating to cleaning, hygiene and infection management in so far as concerning the provision of services by or for the Trust in Trust premises as may be raised to him or her by members of the public, Trust patients and Community Health Councils; and
    - (ii) advise members of the public, Trust patients and Community Health Councils as the case may be of the Trust response to any such matters raised under paragraph 2(a)(i) above; and
    - (iii) ensure the provision of relevant information, including that which promotes awareness, relating to cleaning, hygiene and infection management to Trust patients and members of the public as may be issued from time to time by the Trust.
  - (b) to monitor the number and outcome of complaints which relate to cleaning, hygiene and infection management made to the Trust under their complaints procedure.
  - (c) to report, on at least a quarterly basis, to the public part of full Trust board meetings, matters raised to him or her under paragraph
    (a) above together with any matters arising in connection with such matters.
  - (d) to make the reports under paragraph 2(c) available to the Community Health Council or Community Health Councils for the area which the relevant Trust serves.
  - (e) to ensure the reports under paragraph 2(c) are made available to the public.

#### **Powys Local Health Board**

- **3.** Powys Local Health Board must nominate and publicise the nomination and identity of one of its non officer members to undertake the following:
  - (a) to act as a 'patient's champion' on issues relating to cleaning, hygiene and infection management, more particularly to:-
    - (i) communicate to appropriate Local Health Board personnel relevant matters, including those which promote improvement, relating to cleaning, hygiene and infection management in so far as concerning the provision of services by or for the Local Health Board in Local Health Board premises as may be raised to him or her by members of the public, Local Health Board patients and Community Health Councils; and
    - (ii) advise members of the public, Local Health Board patients and Community Health Councils as the case may be of the Local Health Board response to any such matters raised under paragraph 3(a)(i) above; and
    - (iii) ensure the provision of relevant information, including that which promotes awareness, relating to cleaning, hygiene and infection management to Local Health Board patients and members of the public as may be issued from time to time by the Local Health Board.
  - (b) to monitor the number and outcome of complaints which relate to cleaning, hygiene and infection management made to the Local Health Board under their complaints procedure.
  - (c) to report, on at least a quarterly basis, to the public part of full Local Health Board meetings, matters raised to him or her under paragraph (a) above together with any matters arising in connection with such matters.
  - (d) to make the reports under paragraph 3(c) available to the Community Health Council or Community Health Councils for the area which the Local Health Board serves.
  - (e) to ensure the reports under paragraph 3(c) are made available to the public.
