1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A4042 (Cylchfan Grove Park, Casnewydd i Gylchfan Cwmbrân, Torfaen) (Gwahardd Cerbydau Dros Dro) 2018 a daw i rym ar 9 Mawrth 2018.

2.—(1) Yn y Gorchymyn hwn:

ystyr “cerbyd esempt” (“*exempted vehicle*”) yw unrhyw gerbyd sy'n cael ei ddefnyddio gan y gwasanaethau brys neu mewn cysylltiad â'r gwaith sy'n arwain at y Gorchymyn hwn;

ROAD TRAFFIC, WALES

The A4042 Trunk Road (Grove Park Roundabout, Newport to Cwmbran Roundabout, Torfaen) (Temporary Prohibition of Vehicles) Order 2018

Made 7 March 2018
Coming into force 9 March 2018

The Welsh Ministers, as traffic authority for the relevant length of the A4042 Newport to Shrewsbury Trunk Road, are satisfied that traffic on specified lengths of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. The title of this Order is the A4042 Trunk Road (Grove Park Roundabout, Newport to Cwmbran Roundabout, Torfaen) (Temporary Prohibition of Vehicles) Order 2018 and it comes into force on 9 March 2018.

2.—(1) In this Order:

“exempted vehicle” (“*cerbyd esempt*”) means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

(1) 1984 c.27; section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1. By virtue of S.I. 1999/672, and section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c.32), these powers are now exercisable by the Welsh Ministers in relation to Wales.

ystyr “cyfnod y gwaith” (“*works period*”) yw cyfnodau ysbeidiol sy’n dechrau am 20:00 o’r gloch ar 9 Mawrth 2018 ac sy’n dod i ben pan gaiff yr arwyddion traffig dros dro ar gyfer pob cyfnod gwaith eu symud ymaith yn barhaol;

ystyr “y gefnffordd” (“*the trunk road*”) yw Cefnffordd yr A4042 Casnewydd i Amwythig.

(2) Mae unrhyw gyfeiriad yn y Gorchymyn hwn at erthygl â rhif yn gyfeiriad at yr erthygl sy’n dwyn y rhif hwnnw yn y Gorchymyn hwn.

Gwaharddiad

3. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd, na pheri na chaniatáu i unrhyw gerbyd, ac eithrio cerbyd esempt, fynd ar y darnau o’r gefnffordd a bennir yn yr Atodlen.

4. Nid yw'r gwaharddiad yn erthygl 3 yn gymwys ond ar yr adegau hynny ac i'r graddau hynny y'i dangosir gan arwyddion traffig.

5. Bydd y Gorchymyn hwn yn para am 18 mis ar y mwyaf.

“the trunk road” (“*y gefnffordd*”) means the A4042 Newport to Shrewsbury Trunk Road;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 20:00 hours on 9 March 2018 and ending when the temporary traffic signs for each period of works are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Prohibition

3. No person may, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed on the lengths of the trunk road specified in the Schedule.

Application

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

Duration of this Order

5. The maximum duration of this Order is 18 months.

THE A4042 TRUNK ROAD (GROVE PARK ROUNDABOUT, NEWPORT TO CWMBRAN ROUNDABOUT, TORFAEN) (TEMPORARY PROHIBITION OF VEHICLES) ORDER 2018

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A4042 trunk road between Grove Park Roundabout, Newport and Cwmbran Roundabout, Torfaen.

The effect of the Order is to temporarily prohibit all vehicles, other than those being used by the emergency services and for the works, from proceeding on the lengths of the A4042 specified in the Schedule to this Notice. The alternative route arrangements are also outlined therein.

The temporary prohibition, which will be signed accordingly, is expected to first come into force on 9 March 2018 and operate intermittently overnight (20:00 – 06:00 hours) for a maximum duration of 18 months. Whenever possible, notice of closures will be displayed approximately one week in advance.

The length of the A4042 between Grove Park Roundabout, Newport and Croes-y-Mwyalch Roundabout, Torfaen.

The length of the A4042 between Croes-y-Mwyalch Roundabout and Crown Roundabout, Torfaen. (Local access to be maintained southbound from Cwmbran Roundabout to point of closure).

Llwybrau Eraill

Codir arwyddion priodol i nodi'r gwyriad ar gyfer y llwybrau eraill a byddant yn amrywio gan ddibynnu ar ben y daith a phryd y bydd darn penodol o'r A4042 a ddisgrifir uchod ar gau dros dro i draffig.

Bydd llwybrau eraill ar gael drwy fynd ar yr A4042 Heidenheim Drive, yr A4051 Malpas Road a'r A4051 Cwmbran Drive, fel y bo'n briodol.

The length of the A4042 between Crown Roundabout and Turnpike Roundabout, Torfaen. (Local access to be maintained northbound from Croes-y-Mwyalch Roundabout and southbound from Cwmbran Roundabout to points of closure).

The length of the A4042 between Turnpike Roundabout and Edlogan Way Roundabout, Torfaen. (Local access to be maintained northbound from Croes-y-Mwyalch Roundabout and southbound from Cwmbran Roundabout to points of closure).

The length of the A4042 between Edlogan Way Roundabout and Cwmbran Roundabout, Torfaen. (Local access to be maintained northbound from Croes-y-Mwyalch Roundabout to point of closure).

Alternative Routes

The alternative routes will be signed with appropriate diversion signs and will vary depending on destination and when a particular length of the A4042 described above is temporarily closed to traffic.

Alternative routes will be available via the A4042 Heidenheim Drive, A4051 Malpas Road and A4051 Cwmbran Drive, as appropriate.
