## ROAD TRAFFIC, WALES

The A487 Trunk Road (Blaenporth, Ceredigion) (De-Restriction and 40 mph Speed Limit) Order 2014

*Made* 23 October 2014

*Coming into force* 30 October 2014

The Welsh Ministers, as traffic authority for the Fishguard – Bangor Trunk Road (A487) (“the trunk road”), in exercise of the powers conferred upon them by sections 82(2), 83(1), 84(1) and (2) of the Road Traffic Regulation Act 1984(1), and after consultation with the Chief Officer of the Dyfed - Powys Police, make this Order.

### Title and Commencement

1. This Order comes into force on 30 October 2014. The title to this Order is The A487 Trunk Road (Blaenporth, Ceredigion) (De-Restriction and 40 mph Speed Limit) Order 2014.

### De-Restriction

2. The length of trunk road specified in Schedule 1 to this Order shall cease to be a restricted road for the purpose of Section 81 of the Act of 1984.

### Restriction

3. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour in the length of the trunk road specified in Schedule 2 to this Order.
