Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o Gefnffordd yr A5 Llundain i Gaerdybi, wedi eu bodloni y dylid gwahardd traffig ar ddarn penodedig o'r gefnffordd oherwydd gwaith y bwriedir ei wneud ar y ffordd neu gerllaw iddi.

The Welsh Ministers, as traffic authority for the relevant length of the A5 London to Holyhead Trunk Road, are satisfied that traffic on a specified length of the trunk road should be prohibited because of works proposed on or near the road.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddwyd iddynt gan adran 14(1) a (4) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A5 (Cylchfan Halton i Gylchfan Whitehurst, Y Waun, Bwrdeistref Sirol Wrecsam) (Gwahardd Cerbydau Dros Dro) 2018 a daw i rym ar 1 Ebrill 2018.

1. The title of this Order is the A5 Trunk Road (Halton Roundabout to Whitehurst Roundabout, Chirk, Wrexham County Borough) (Temporary Prohibition of Vehicles) Order 2018 and it comes into force on 1 April 2018.

ystyr “cerbyd esempt” (“*exempted vehicle*”) yw unrhyw gerbyd sy'n cael ei ddefnyddio gan y gwasanaethau brys neu mewn cysylltiad â'r gwaith sy'n arwain at y Gorchymyn hwn;

“exempted vehicle” (“*cerbyd esempt*”) means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

ystyr “cyfnod y gwaith” (“*works period*”) yw cyfnodau ysbeidiol sy'n dechrau am 19:00 o'r gloch ar 1 Ebrill 2018 ac sy'n dod i ben pan gaiff yr arwyddion traffig dros dro ar gyfer pob cyfnod gwaith eu symud ymaith;

ystyr “y gefnffordd” (“*the trunk road*”) yw Cefnffordd yr A5 Llundain i Gaerdybi.

(2) Mae unrhyw gyfeiriad yn y Gorchymyn hwn at erthygl â rhif yn gyfeiriad at yr erthygl sy'n dwyn y rhif hwnnw yn y Gorchymyn hwn.

Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd, na pheri na chaniatáu i unrhyw gerbyd, ac eithrio cerbyd esempt, fynd ar y darn o'r gefnffordd i'r gogledd o'r Waun ym Mwrdeistref Sirol Wrecsam sy'n ymestyn o ochr orllewinol Cylchfan Halton hyd at ochr ddwyreiniol Cylchfan Whitehurst.

“the trunk road” (“*y gefnffordd*”) means the A5 London to Holyhead Trunk Road;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 19:00 hours on 1 April 2018 and ending when the temporary traffic signs for each period of works are removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Prohibition

3. No person may, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed on the length of the trunk road north of Chirk in the County Borough of Wrexham that extends from the western side of Halton Roundabout to the eastern side of Whitehurst Roundabout.

Application

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

Duration of this Order

5. The maximum duration of this Order is 18 months.

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A5 rhwng Cylchfan Halton a Chylchfan Whitehurst, i'r gogledd o'r Waun, Bwrdeistref Sirol Wrecsam.

Effaith y Gorchymyn yw gwahardd dros dro pob cerbyd, ac eithrio'r rheini sy'n cael eu defnyddio gan y gwasanaethau brys ac ar gyfer y gwaith, rhag teithio rhwng Cylchfan Halton a Chylchfan Whitehurst.

Disgwylir y bydd y gwaharddiad dros dro, y codir arwyddion priodol ynghylch ei hyd a'i led, yn dod i rym ar 1 Ebrill 2018 ac yn weithredol yn ysbeidiol dros nos (19:00 – 06:00 o'r gloch) am gyfnod o 18 mis ar y mwyaf.

**THE A5 TRUNK ROAD (HALTON
ROUNDAABOUT TO WHITEHURST
ROUNDAABOUT, CHIRK, WREXHAM COUNTY
BOROUGH) (TEMPORARY PROHIBITION OF
VEHICLES) ORDER 2018**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984 which is necessary to undertake works on or near the A5 trunk road between Halton Roundabout and Whitehurst Roundabout, north of Chirk, Wrexham County Borough.

The effect of the Order is to temporarily prohibit all vehicles, other than those being used by the emergency services and for the works, from travelling between Halton Roundabout and Whitehurst Roundabout.

The alternative route for westbound vehicles from Halton Roundabout will be via the southbound A5 to Gledrid Roundabout and northbound B5070 to re-join the trunk road at Whitehurst Roundabout: vice versa for eastbound vehicles from Whitehurst Roundabout.

The prohibition, which will be signed accordingly, is expected to come into force on 1 April 2018 and operate intermittently overnight (19:00 – 06:00 hours) for a maximum duration of 18 months.
