Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darnau perthnasol o Draffordd yr M4 Llundain i Dde Cymru a Thraffordd yr A48(M), wedi eu bodloni y dylid gwahardd traffig ar ddarnau penodedig o'r traffyrdd oherwydd gwaith y bwriedir ei wneud ar y traffyrdd neu gerllaw iddynt.

The Welsh Ministers, as traffic authority for the relevant lengths of the M4 London to South Wales Motorway and the A48(M) Motorway, are satisfied that traffic on specified lengths of the motorways should be prohibited because of works proposed on or near the motorways.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1) a (4) a 124 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), a pharagraff 27 o Atodlen 9 iddi, yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) and 124(1)(d) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. Enw'r Gorchymyn hwn yw Gorchymyn Traffordd yr M4 (Cyffordd 23a (Magwyr), Sir Fynwy i Gyffordd 34 (Meisgyn), Rhondda Cynon Taf) a Thraffordd yr A48(M) (Cyffordd 29 (Cas-bach), Casnewydd i Gyffordd 29A (Llaneirwg), Caerdydd) (Gwahardd Cerbydau Dros Dro) (Rhif 2) 2018 a daw i rym ar 3 Ionawr 2019.

1. The title of this Order is the M4 Motorway (Junction 23a (Magor), Monmouthshire to Junction 34 (Miskin), Rhondda Cynon Taf) & The A48(M) Motorway (Junction 29 (Castleton), Newport to Junction 29A (St Mellons), Cardiff) (Temporary Prohibition of Vehicles) (No.2) Order 2018 and it comes into force on 3 January 2019.

ystyr “cyfnod y gwaith” (“*works period*”) yw cyfnodau ysbeidiol sy’n dechrau am 20:00 o’r gloch ar 3 Ionawr 2019 ac sy’n dod i ben pan gaiff yr arwyddion traffig dros dro ar gyfer pob cyfnod gwaith eu symud ymaith;

ystyr “y traffyrdd” (“*the motorways*”) yw Traffordd yr M4 Llundain i Dde Cymru a Thraffordd yr A48(M).

3. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd, ac eithrio cerbyd esempt, ar y darnau o’r traffyrdd a bennir yn yr Atodlen i’r Gorchymyn hwn.

4. Ni fydd y gwaharddiad yn erthygl 3 yn gymwys ond ar yr adegau ac i’r graddau y bydd arwyddion traffig yn ei dangos.

2. In this Order:

“exempted vehicle” (“*cerbyd esempt*”) means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

“the motorways” (“*y traffyrdd*”) means the M4 London to South Wales Motorway and the A48(M) Motorway;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 20:00 hours on 3 January 2019 and ending when the temporary traffic signs for each period of works are removed.

Prohibition

3. No person may, during the works period, drive any vehicle, other than an exempted vehicle, on the lengths of the motorways specified in the Schedule to this Order.

Application

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

Revocation

5. The M4 Motorway (Junction 23a (Magor), Monmouthshire to Junction 34 (Miskin), Rhondda Cynon Taf) & The A48(M) Motorway (Junction 29 (Castleton), Newport to Junction 29A (St Mellons), Cardiff) (Temporary Prohibition of Vehicles) Order 2018(2) is revoked.

Duration of this Order

6. The maximum duration for this Order is 18 months.

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar Draffordd yr M4 rhwng Cyffordd 23a (Magwyr), Sir Fynwy a Chyffordd 34 (Meisgyn), Rhondda Cynon Taf a Thraffordd yr A48(M) rhwng Cyffordd 29 (Cas-bach), Casnewydd a Chyffordd 29A (Llaneirwg), Caerdydd, neu gerllaw iddynt.

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the M4 motorway between Junction 23a (Magor), Monmouthshire and Junction 34 (Miskin), Rhondda Cynon Taf and the A48(M) motorway between Junction 29 (Castleton), Newport and Junction 29A (St Mellons), Cardiff.

The effect of the Order is to temporarily prohibit all vehicles, other than those being used by the emergency services and for the works, from proceeding on certain lengths of the M4/A48(M) within the overall lengths described in the Schedule to this Notice when work is required at a particular site. The alternative route arrangements are also described in the Schedule.

It is expected that the prohibitions, which will be signed accordingly, will come into force on 3 January 2019 and operate intermittently overnight (20:00 hours – 06:00 hours) for a maximum period of 18 months. Where practical, advance notice of the prohibitions will be displayed approximately one week before the closure of a specified length of the motorways.

SCHEDULE

Temporary Prohibition of Vehicles & Alternative Routes

The lengths of the westbound and eastbound carriageways of the M4 motorway between Junction 23a (Magor) and Junction 34 (Miskin), including all westbound and eastbound exit and entry slip roads between these junctions.

The length of the A48(M) motorway between Junction 29 (Castleton) and Junction 29A (St Mellons).

Alternative route arrangements

The alternative routes will be signed with appropriate diversion signs and will vary depending on destination and when a particular length of the M4 or A48(M) is temporarily closed to traffic.

Alternative routes will be available via the main M4, M48, A4042, A4051, A4810, A48, B4591, A467, A4232, A48(M), A470, A473 and A4119, as appropriate.
