Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o Draffordd yr M4, wedi eu bodloni y dylid gwahardd traffig ar ddarnau penodedig o'r draffordd oherwydd gwaith y bwriedir ei wneud ar y draffordd neu gerllaw iddi.

The Welsh Ministers, as traffic authority for the relevant length of the M4 Motorway, are satisfied that traffic on specified lengths of the motorway should be prohibited because of works proposed on or near the motorway.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adrannau 14(1) a (4) a 124 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), a pharagraff 27 o Atodlen 9 iddi, yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by sections 14(1) and (4) and 124 of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984(1), make this Order.

**Title, Commencement and Interpretation**

1. Enw'r Gorchymyn hwn yw Gorchymyn Traffordd yr M4 (Cyffordd 34 (Meisgyn), Rhondda Cynon Taf i Gyffordd 49 (Pont Abraham), Sir Gaerfyrddin) (Gwahardd Cerbydau Dros Dro) 2018 a daw i rym ar 24 Medi 2018.

1. The title of this Order is the M4 Motorway (Junction 34 (Miskin), Rhondda Cynon Taf to Junction 49 (Pont Abraham), Carmarthenshire) (Temporary Prohibition of Vehicles) Order 2018 and it comes into force on 24 September 2018.

"exempted vehicle" ("*cerbyd esempt*") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"works period" ("*cyfnod y gwaith*") means intermittent periods commencing at 20:00 hours on 24 September 2018 and ending when the temporary traffic signs for each period of works are removed.

### Prohibition

3. No person may, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed on the lengths of the motorway specified in the Schedule to this Order.

### Application

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

### Revocation

5. The M4 Motorway (Junction 37 (Pyle), Bridgend to Junction 47 (Penllergaer), Swansea) (Temporary Prohibition of Vehicles) Order 2018(2) is revoked.

### Duration of this Order

6. The maximum duration for this Order is 18 months.

**THE M4 MOTORWAY (JUNCTION 34

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the M4 motorway between Junction 34 (Miskin), Rhondda Cynon Taf and Junction 49 (Pont Abraham), Carmarthenshire.

The effect of the Order is to temporarily prohibit all vehicles, other than those being used by the emergency services and for the works, from proceeding on specified lengths of the M4 within the overall lengths described in the Schedule to this Notice when work is required at a particular site. The alternative route arrangements are also described in the Schedule.

It is expected that the prohibitions, which will be signed accordingly, will come into force on 24 September 2018 and operate intermittently overnight (20:00 hours – 06:00 hours) for a maximum period of 18 months. Whenever possible, notice of a prohibition will be displayed approximately one week before the closure of a specified length of the motorway. Advance notice of any changes to times and dates will also be displayed before any rescheduled work.

### **Alternative route arrangements**

The alternative routes will be indicated with appropriate diversion signs and will vary depending on destination and when a particular length of the M4 is temporarily closed to traffic.

Alternative routes will be available via the main M4 (both carriageways), A4232, A48, A473, A4229, A4241, B4286, A4107, A474, A465, A4230, A4067, A483, A484 and A4138, as appropriate.
