### EXPLANATORY NOTE

(This note is not part of the Order)

The Order amends the Neath to Abergavenny Trunk Road (A465) (Abergavenny to Hirwaun Dualling and Slip Roads) and East of Abercynon to East of Dowlais Trunk Road (A4060), Cardiff to Glan Conwy Trunk Road (A470) (Connecting Roads) Order 1999 as amended by a 2012 Amendment Order and a 2014 Amendment Order, in respect of the length of the main new trunk road between Dowlais Top and Hirwaun (known as Sections 5 and 6); it also provides for some changes to junction arrangements including the amendment of new slip roads to be provided and provision of additional slip roads, the omission of slip roads and the amendment of a connecting road.

The 2012 Amendment Order amended the 1999 Order in respect of the lengths of the new trunk road (A465) between Brynmawr and Tredegar (known as Section 3). The 2014 Amendment Order amended the 1999 Order in respect of the lengths of the new trunk road (A465) between Gilwern and Brynmawr (known as Section 2). This Order further amends the 1999 Order in respect of the lengths of the new trunk roads (A465 and A470) between Dowlais Top and Hirwaun (Sections 5 and 6).

Article 2 amends the description of the deposited plans in the 1999 Order in respect of the line of Sections 5 and 6 of the new trunk road (A465) by replacing Key Plan 2, Site Plan 7, Site Plan 8, Site Plan 9, Site Plan 10 and Site Plan 11 in the existing

Article 4 amends Schedule 2 to the 1999 Order in respect of Sections 5 and 6 by amending the description of a connecting road included in the description of the new slip roads.

Article 5 amends Schedule 2 to the 1999 Order in respect of Sections 5 and 6 by inserting new descriptions of slip roads to be provided at a realigned junction.

Article 6 amends Schedule 2 to the 1999 Order in respect of Sections 5 and 6 by inserting descriptions of new slip roads to be provided at an additional junction.

Article 7 amends Schedule 3 to the 1999 Order in respect of Sections 5 and 6 by amending a description of a connecting road to be provided.

## Title, Interpretation and Commencement

1. #### **Omission of Slip Roads and Addition of New Slip Roads**

3. In Schedule 2 of the Principal Order, omit paragraphs 16 to 18 and insert –

"16. Grade separated junction located north of Pen-y-Dre High School and north of Merthyr Tydfil to join Gurnos Ring Road and serve Pant Industrial Estate and Galon Uchaf to include four routes to connect the eastbound and westbound carriageways of the main new trunk road with a new Gurnos roundabout to be provided for in the associated side roads order, and given the reference numbers 50, 51, 52 and 53 on the deposited plan at Site Plan number 8A (as amended) as follows:-

A route some 395 metres in length commencing at a point 2260 metres north west of the centre point of Rocky Road roundabout on the westbound carriageway of the main new trunk road in a generally north westerly direction to a point 200 metres south west of the property known as Dan-y-Castell Farm, to join the circulatory carriageway of a new Gurnos roundabout to be provided for in the associated side roads order (the new trunk road along this route being given the reference number 50 on the deposited plan at Site Plan number 8A (as amended)).

A route some 421 metres in length commencing at a point 150 metres south west of the property known as Dan-y-Castell Farm (on the circulatory carriageway of a new Gurnos roundabout to be provided for in the associated side roads order) in a generally south easterly direction to join the eastbound carriageway of the main new trunk road at a point 205 metres generally north west of the centre point of the Rocky Road Roundabout (the new trunk road along this route

A route some 555 metres in length commencing at a point on the westbound carriageway of the main new trunk road 90 metres south east of the junction between the existing A465 trunk road and the road leading to the Jah Jireh Nursing Home, in a generally southwesterly direction to a point 155 metres south west of the junction between the existing A465 trunk road and the unclassified road leading to Croesbychan (on the circulatory carriageway of a new roundabout to be provided for in the associated side roads order)(the new trunk road along this route being given the reference number 41 on the deposited plan at Site Plan number 10A (as amended)).

A route some 522 metres in length commencing at a point 200 metres north of the property known as Ty Gwyn Farm (on the circulatory carriageway of a new roundabout to be provided for in the associated side roads order) in a generally north westerly direction to join the eastbound carriageway of the main new trunk road at a point 300 metres north of the junction between the unclassified road leading to Croesbychan and the road leading to Llwydcoed Crematorium (the new trunk road along this route being given the reference number 42 on the deposited plan at Site Plan number 10A (as amended)).

A route some 516 metres in length commencing at a point 240 metres north west of the junction between the existing A465 trunk road and the unclassified road leading to Croesbychan (on the circulatory carriageway of a new roundabout to be provided for in the associated side roads order) in a generally north easterly direction to join the eastbound carriageway of the main new trunk road at a point 200 metres east of the junction between the existing A465 trunk road and the road leading to the Jan Jireh Nursing Home (the new trunk road along this route being given the reference number 43 on the deposited plan at Site Plan number 10A (as amended))."

Four routes to connect the eastbound and westbound carriageways of the main new trunk road with two linked roundabouts (to be provided for in the associated side roads order), located south east of the property known as Lynwood and north east of Hirwaun (the new trunk roads along these routes being given the numbers 54, 55, 56 and 57 on the deposited plan at Site Plan No. 11A as amended).

A route some 585 metres in length commencing at a point on the eastbound carriageway of the main new trunk road 350 metres south east of Court Farm, in a generally north easterly direction, to a point 100 metres north east of the property known as Lynwood (on the circulatory carriageway of a new roundabout to be provided for in the associated side roads order) (the new trunk road along this route being given the reference number 54 on the deposited plan at Site Plan number 11A (as amended)).

A route some 475 metres in length commencing at a point 335 metres south of Nantmoel Farm (on the circulatory carriageway of a new roundabout to be provided for in the associated side roads order) in a generally north easterly direction to join the eastbound carriageway of the main new trunk road at a point 210 metres east of Nantmoel Farm (the new trunk road along this route being given the reference number 55 on the deposited plan at Site Plan number 11A (as amended)).

A route some 582 metres in length commencing at a point on the westbound carriageway of the main new trunk road 350 metres east of Nantmoel Farm in a generally south westerly direction to a point 110 metres west of the property known as La Plat (on the circulatory carriageway of a new roundabout to be provided for in the associated side roads order) (the new trunk road along this route being given the reference number 56 on the deposited plan at Site Plan number 11A (as amended)).

A route some 467 metres in length commencing at a point 140 metres west of La Plat (on the circulatory carriageway of a new roundabout to be provided for in the associated side roads order) in a generally south westerly direction to join the eastbound carriageway of the main new trunk road at a point 380


