The Authorised Works

1. The Welsh Ministers are authorised, in relation to the new motorway:

- a. to stop up private means of access to premises;
- b. to provide new means of access to premises.

2. (1) The works authorised by article 1 are indicated in the Schedule to this Order and are shown on the site plan that is included in the deposited plan that accompanies this Order in the following manner:-

- a. the length of private means of access to be stopped up is described in the Schedule (the distance stated being approximate only), and is given the reference number shown on

(2) The deposited plan marks the position of the new motorway in relation to the authorised works shown on the deposited plan.

Stopping Up of Private Means of Access

3. It is hereby declared that the Welsh Ministers are satisfied as respects the private means of access to premises the stopping up of which is authorised by this Order, that another reasonably convenient means of access to premises will be provided in pursuance of this Order before that private means of access is stopped up.

Interpretation

4. In this Order:-

(1) all measurements of distance are measured along the route of the relevant highway or means of access to premises as the case may be;

The Welsh Ministers are considering implementing a project for the construction of a new section of M4 motorway to the south of Newport to include online and off line works and side road improvements. This project is subject to an Environmental Impact Assessment in accordance with Part VA of the Highways Act 1980 (as amended) and EC Directive 2011/92/EU. Therefore the Welsh Ministers published an Environmental Statement (ES) on 10 March 2016.

Following publication of the ES, three Environmental Statement Supplements (ESS) were published on 5 September 2016, 13th December 2016 and 21 March 2017. These provide errata, additional data and clarifications, and an environmental assessment of scheme design changes between March 2016 and February 2017. All supplements and the ES should be read together.
