The Welsh Ministers have made an Order under sections 14(1) and 124 of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984.

The effect of the Order is to revoke the A40 Trunk Road and Link Road (Travellers' Rest Junction, Carmarthenshire) (Temporary Prohibition of Vehicles and 30 MPH Speed Limit) Order 2017 & A40 Trunk Road and Link Road (Travellers' Rest, Carmarthenshire) (Temporary 30 MPH Speed Limit) Order 2018 as the Welsh Ministers propose to make a permanent 50mph & 30mph speed limit Order at this location.

It is expected that the Order will come into force on 1 November 2019.
