ROAD TRAFFIC

THE TRUNK ROAD (TYCROES SQUARE, AMMANFORD)  
(PROHIBITION OF WAITING) ORDER 1968

MADE 2nd December 1968

COMING INTO OPERATION 23rd December 1968

The Secretary of State in exercise of his powers under section 1(1), (2) and (3) and section 108 of the Road Traffic Regulation Act 1967(a), and of all other powers him enabling in that behalf hereby makes the following Order:-

1. Save as provided in Article 2 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait in the length of road specified in the Schedule to this Order.
2. Nothing in Article 1 of this Order shall render it unlawful to cause or permit any vehicle to wait in the length of road referred to therein for so long as may be necessary:-
  - (a) to enable a person to board or alight from the vehicle;
  - (b) to enable goods to be loaded on to or unloaded from the vehicle;
  - (c) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the length of road so referred to or the laying, erection, alteration or repair in or near the said length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act 1878(b);
  - (d) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority in pursuance of statutory powers or duties; or
  - (e) if the vehicle is a stage carriage or an express carriage.
3. The Interpretation Act 1889(c) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
4. This Order shall come into operation on the 20th December 1968 and may be cited as the Trunk Road (Tycroes Square, Ammanford) (Prohibition of Waiting) Order 1968

SCHEDULE

That length of the Swansea - Manchester Trunk Road (A.483), at Tycroes in the County of Carmarthen, known in part as Pontardulais Road and in part as Ammanford Road, which extends from a point 63<sup>m</sup> yards north of its junction with Tycroes Road to a point 60<sup>m</sup> yards south-west of its junction with Penygarn Road, a distance of approximately 140 yards.
