Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer Cefnffordd yr A477, wedi eu bodloni y dylid cyfyngu ar draffig a/neu ei wahardd ar ddarnau penodedig o'r gefnffordd oherwydd gwaith y bwriedir ei wneud ar y ffordd neu gerllaw iddi.

The Welsh Ministers, as traffic authority for the A477 Trunk Road, are satisfied that traffic on specified lengths of the trunk road should be restricted and/or prohibited because of works proposed on or near the road.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddwyd iddynt gan adran 14(1), (4) a (7) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1), make this Order.

**Title, Commencement and Interpretation**

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A477 (East Williamston i Amroth Road, i'r dwyrain o Gilgeti, Sir Benfro) (Cyfyngiadau Cyflymder Dros Dro a Dim Goddiweddyd) 2020 a daw i rym ar 13 Chwefror 2020.

1. The title of this Order is the A477 Trunk Road (East Williamston to Amroth Road, east of Kilgetty, Pembrokeshire) (Temporary Speed Restrictions & No Overtaking) Order 2020 and it comes into force on 13 February 2020.

**4.** Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd yn gyflymach na 10 milltir yr awr ar y darnau o'r gefnffordd a bennir yn yr Atodlenni i'r Gorchymyn hwn.

**5.** Ni chaiff neb, yn ystod cyfnod y gwaith, ddefnyddio cerbyd na chaniatáu i gerbyd gael ei ddefnyddio yn y fath fodd fel ei fod yn goddiweddyd unrhyw gerbyd arall ar y darnau o'r gefnffordd a bennir yn yr Atodlenni i'r Gorchymyn hwn ar yr adegau hynny pan fo'r cyfyngiad y cyfeirir ato yn erthygl 4 yn weithredol.

(2) Diwygiwyd adran 87 gan baragraff 55 o Atodlen 1 i Ddeddf Gwasanaethau Tân ac Achub 2004 (p. 21), paragraff 42 o Atodlen 4 i Ddeddf Trosedd Cyfundrefnol Difrifol a'r Heddlu 2005 (p. 15), paragraff 29(2) o Atodlen 8 i Ddeddf Trosedd a'r Llysoedd 2013 (p. 22) ac adran 50(4) a (5) o Ddeddf Dadreoleiddio 2015 (p. 20).

- (a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984(2); and
- (b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—
  - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
  - (ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk road” (“*y gefnffordd*”) means the A477 St Clears to Pembroke Dock Trunk Road;

“works period” (“*cyfnod y gwaith*”) means the period commencing at 00:01 hours on 13 February 2020 and ending when the temporary traffic signs are permanently removed.

### Restrictions and Prohibition

**3.** No person may, during the works period, drive any vehicle at a speed exceeding 40 miles per hour on the lengths of the trunk road specified in Schedule 1 to this Order.

**4.** No person may, during the works period, drive any vehicle at a speed exceeding 10 miles per hour on the lengths of the trunk road specified in the Schedules to this Order.

**5.** No person may, during the works period, use or permit the use of a vehicle in such a way that it overtakes any other vehicle on the lengths of the trunk road specified in the Schedules to this Order during such times as the restriction referred to in article 4 is in operation.

## Application

6.—(1) The restrictions and prohibition in articles 3, 4 and 5 apply only during such times and to such extent as indicated by traffic signs.

(2) No speed limits imposed by this Order apply to an exempted vehicle.

## Suspension

7. Any statutory provisions restricting the speed of vehicles on the lengths of the trunk road specified in the Schedules to this Order are suspended during such times as the restrictions specified in articles 3 and 4 are in operation.

## Duration of this Order

8. The maximum duration of this Order is 18 months.

**THE A477 TRUNK ROAD (EAST WILLIAMSTON TO AMROTH ROAD, EAST OF KILGETTY, PEMBROKESHIRE) (TEMPORARY SPEED RESTRICTIONS & NO OVERTAKING) ORDER 2020**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A477 trunk road between East Williamston and Amroth Road, east of Kilgetty, Pembrokeshire.

The effect of the Order is to temporarily:

i. impose either a 40 mph or 10 mph speed limit and prohibit overtaking on the lengths of the A477 described in Schedule 1 to this Notice; and

ii. impose a 10 mph speed limit and prohibit overtaking on the length of the A477 described in Schedule 2 to this Notice.

The 10 mph speed limit will only apply during convoy working and no overtaking will be permitted at these times.

The temporary restrictions and prohibition are expected to come into force at 00:01 hours on 13 February 2020 and remain in force until 23:59 hours on 13 March 2020 or until the temporary traffic signs are permanently removed.

Although the Order is only expected to operate during the dates specified above it will remain valid for a maximum period of 18 months, as a contingency, should the work need to be rescheduled or consequential or other work is required. Advance notice of any changes to times and dates will be displayed before any rescheduled work.
