This discussion paper has been written by officials of the Welsh Government. Ministers have not had an opportunity to comment on the contents. Exemplifications of changes are provided simply to inform discussion by DSG members. They are not Welsh Government proposals or statements of Government policy for or against changes.

### The treatment of transfers of new responsibilities and the funding floor

#### Summary

1. This paper evaluates the current treatment of funding for new responsibilities under the funding floor within the settlement and investigates the financial impact if this was to be changed.

## Views sought

2. DSG members are asked to express their preference on whether to passport new responsibilities through the funding floor, or to remain with the current mechanism.

### **Background**

- 3. Currently the funding for new responsibilities is added to the settlement prior to the consideration of any floor funding.
- 4. In the November 2018 DSG meeting, the group considered a paper outlining funding that could be added to the settlement between provisional and final, with a provisional floor already having been set.
- 5. DSG queried the rationale behind new responsibilities being included prior to the floor calculations as, without a revision of the floor, this could lead to some authorities on the floor seeing no financial benefit, while still being required to undertake additional responsibilities. This raised the question around whether new responsibilities should be passported through the floor, to ensure all the additional funding is passed on to each local authority. The WLGA's consultation response also queried whether funding for new responsibilities should be passported through the floor mechanism.
- 6. This paper explores the financial impact of this suggestion. It's important to note that the overall decision of the funding floor lays with Minister for Housing and Local Government.

#### **Analysis**

- 7. This section looks at the current distribution of the 2019-20 settlement (with a minus 0.3% floor) and compares this to the distribution we would arrive at were the capital limits for residential care new responsibility taken outside of the floor mechanism.
- 8. While the level of the floor is a matter for the Minister for Housing and Local Government, for comparison purposes, this analysis sets the highest affordable floor level (after the removal of the new responsibility), to 1 decimal place, given the amount of floor funding used in delivering the actual minus 0.3% settlement floor and

recycles the rest of the funding through the model, before adding back in the new responsibility.

- 9. The table in Annex A shows the calculation of AEF when the new responsibility is passported through the floor funding calculation. The new responsibility has been removed at the stage prior to considering the like for like comparison with the previous year. Once the floor has been set, the funding for the new responsibility is added back in.
- 10. As shown in Annex A, removing the new responsibilities prior to considering the floor level enables the setting of a minus 0.5% floor, within the constraints of the overall funding available for 2019-20.
- 11. Five authorities remain on the floor (Monmouthshire, Powys, Conwy, Isle of Anglesey and Flintshire). After the funding for new responsibilities are added back in, the funding for the five authorities ranges from a 0.34% reduction for Flintshire to a 0.29% reduction for Monmouthshire and Conwy.
- 12. Comparing the overall funding in the 2019-20 final settlement and the option outlined above, sees 2 authorities getting less funding and 20 authorities receiving more (see the table in annex B).
- 13. Flintshire's funding decreases from £188.980m to £188.905m (a net decrease of £75k) if the option outlined above was used, compared with the 2019-20 final settlement. Similarly Isle of Anglesey's funding would decrease from £95.791m to £95.771m (a net decrease of £19.5k).
- 14. On the other side, Monmouthshire would see the largest increase in their funding from £93.229m to £93.243m (net increase of £13.5k).
- 15. If the new responsibilities are to be passported through the floor mechanism, members are asked to consider if this should be for only the first year of the transfer; until the financial information is fully fed into the Revenue Outturn (RO) data (2 years); or until the new responsibility is no longer separately identified in the settlement.

#### Conclusion

- 16. DSG are asked to consider the analysis and the potential impact of implementing this change and to make a recommendation on whether to passport new responsibilities through the funding floor, or to remain with the current mechanism.
- 17. If the group agree that new responsibilities should be passported, they are also asked to recommend for how many years this should take place.
