Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o Gefnffordd yr A466, drwy arfer y pwerau a roddir iddynt gan adrannau 84(1)(a), 84(2) a 124(1)(d) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1) a pharagraff 27(1) o Atodlen 9 iddi, ac ar ôl ymgynghori â Phrif Swyddog Heddlu Gwent, yn gwneud y Gorchymyn hwn.

The Welsh Ministers, as traffic authority for the relevant length of the A466 Trunk Road, in exercise of the powers conferred upon them by sections 84(1)(a), 84(2) and 124(1)(d) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984(1), and after consultation with the Chief Officer of Gwent Police, make this Order.

Title, Commencement and Interpretation

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A466 (Cylchfan Newhouse i Gylchfan High Beech, Ger Cas-gwent, Sir Fynwy) (Terfynau Cyflymder 40 mya a 50 mya) 2020 a daw i rym ar 27 Chwefror 2020.

1. The title of this Order is the A466 Trunk Road (Newhouse Roundabout to High Beech Roundabout, Near Chepstow, Monmouthshire) (40 mph & 50 mph Speed Limits) Order 2020 and it comes into force on 27 February 2020.

ystyr "cerbyd esempt" ("*exempted vehicle*") yw:

"exempted vehicle" ("*cerbyd esempt*") means:

(a) unrhyw gerbyd sy'n cael ei ddefnyddio at y dibenion a ddisgrifir yn adran 87 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(2);

(a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984(2);

ystyr “lluoedd arbennig” (“*special forces*”) yw'r unedau hynny o'r lluoedd arfog y mae Cyfarwyddwr y Lluoedd Arbennig yn gyfrifol am gynnal eu galluoedd neu sydd am y tro yn ddarostyngedig i reolaeth weithredol y Cyfarwyddwr hwnnw.

4. Ni chaiff neb yrru unrhyw gerbyd modur, ac eithrio cerbyd esempt, yn gyflymach na 50 milltir yr awr ar y darn o'r gefnffordd a bennir yn Atodlen 2 i'r Gorchymyn hwn.

(b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—

(i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or

(ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk road” (“*y gefnffordd*”) means the A466 London to Fishguard Trunk Road.

Restrictions

3. No person may drive any motor vehicle, other than an exempted vehicle, at a speed exceeding 40 miles per hour on the lengths of the trunk road specified in Schedule 1 to this Order.

4. No person may drive any motor vehicle, other than an exempted vehicle, at a speed exceeding 50 miles per hour on the length of the trunk road specified in Schedule 2 to this Order.

Revocation

5. The A466 Trunk Road (Wye Valley Link Road, Chepstow, Gwent) (De-restriction) Order 1994(3) is revoked.

The Welsh Ministers have made an Order in exercise of their powers under sections 84(1) and (2) and 124(1)(d) of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984, which comes into force on 27 February 2020.

The effect of the Order is to impose 40 mph and 50 mph speed limits on the lengths of the A466 trunk road at Chepstow, Monmouthshire described in the Schedules to this Notice. The existing derestriction will be revoked.
