Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o Gefnffordd yr A483, wedi eu bodloni y dylid gwahardd traffig a/neu gyfyngu arno ar ddarn penodedig o'r gefnffordd oherwydd gwaith y bwriedir ei wneud ar y ffordd neu gerllaw iddi.

The Welsh Ministers, as traffic authority for the relevant length of the A483 Trunk Road, are satisfied that traffic on a specified length of the trunk road should be prohibited and/or restricted because of works proposed on or near the road.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1), (4), a (7) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A483 (Ffordd Osgoi Newbridge, Bwrdeistref Sirol Wrecsam) (Gwaharddiadau a Chyfyngiadau Traffig Dros Dro) 2020 a daw i rym ar 1 Mawrth 2020.

1. The title of this Order is the A483 Trunk Road (Newbridge Bypass, Wrexham County Borough) (Temporary Traffic Prohibitions & Restrictions) Order 2020 and it comes into force on 1 March 2020.

ystyr "cerbyd esempt" ("*exempted vehicle*") yw:

"exempted vehicle" ("*cerbyd esempt*") means:

 - (i) ac sydd wedi ei hyfforddi i yrru ar gyflymderau uchel ac sy'n gweithredu wrth ymateb, neu wrth ymarfer ymateb, i argyfwng diogelwch gwladol; neu
 - (ii) at ddiben hyfforddi person i yrru cerbydau ar gyflymderau uchel;

ystyr “cyfnod y gwaith” (“*works period*”) yw cyfnodau ysbeidiol sy'n dechrau am 19:00 o'r gloch ar 1 Mawrth 2020 ac sy'n dod i ben pan gaiff yr arwyddion traffig dros dro ar gyfer pob cyfnod gwaith eu symud ymaith;

ystyr “y gefnffordd” (“*the trunk road*”) yw Cefnffordd yr A483 Abertawe i Fanceinion a elwir yn Ffordd Osgoi Newbridge, Bwrdeistref Sirol Wrecsam sy'n ymestyn o ganolbwynt Cyffordd 1 (Cyfnewidfa Rhiwabon) hyd at ei chyffordd ag ochr ogleddol Cylchfan Halton;

ystyr “lluoedd arbennig” (“*special forces*”) yw'r unedau hynny o'r lluoedd arfog y mae Cyfarwyddwr y Lluoedd Arbennig yn gyfrifol am gynnal eu galluoedd neu sydd am y tro yn ddarostyngedig i reolaeth weithredol y Cyfarwyddwr hwnnw.

Gwaharddiadau a Chyfyngiadau

3. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd, ac eithrio cerbyd esempt, ar y darn o'r gefnffordd a bennir yn erthygl 2.

4. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd yn gyflymach na 50 milltir yr awr ar y darn o'r gefnffordd a bennir yn erthygl 2.

5. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd yn gyflymach na 40 milltir yr awr ar y darn o'r gefnffordd a bennir yn erthygl 2.

(2) Diwygiwyd adran 87 gan baragraff 55 o Atodlen 1 i Ddeddf Gwasanaethau Tân ac Achub 2004 (p. 21), paragraff 42 o Atodlen 4 i Ddeddf Troseddu Cyfundrefnol Difrifol a'r Heddlu 2005 (p. 15), paragraff 29(2) o Atodlen 8 i Ddeddf Troseddu a'r Llysoedd 2013 (p. 22) ac adran 50(4) a (5) o Ddeddf Dadreoleiddio 2015 (p. 20).

- (a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984(2);
- (b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—
 - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
 - (ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk road” (“*y gefnffordd*”) means the A483 Swansea to Manchester Trunk Road known as Newbridge Bypass, Wrexham County Borough that extends from the centre-point of Junction 1 (Ruabon Interchange) to its junction with the northern side of Halton Roundabout;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 19:00 hours on 1 March 2020 and ending when the temporary traffic signs for each period of works are removed.

Prohibitions and Restrictions

3. No person may, during the works period, drive any vehicle, other than an exempted vehicle, on the length of the trunk road specified in article 2.

4. No person may, during the works period, drive any vehicle at a speed exceeding 50 miles per hour on the length of the trunk road specified in article 2.

5. No person may, during the works period, drive any vehicle at a speed exceeding 40 miles per hour on the length of the trunk road specified in article 2.

(2) Section 87 was amended by the Fire and Rescue Services Act 2004 (c.21), Schedule 1, paragraph 55, the Serious Organised Crime and Police Act 2005 (c.15), Schedule 4, paragraph 42, the Crime and Courts Act 2013 (c.22), Schedule 8, paragraph 29(2) and the Deregulation Act 2015 (c.20), section 50(4) and (5).

6. Ni chaiff neb, yn ystod cyfnod y gwaith, ddefnyddio cerbyd na chaniatáu i gerbyd, ac eithrio cerbyd esempt, gael ei ddefnyddio yn y fath fodd fel ei fod yn goddiweddyd unrhyw gerbyd arall ar y darn o'r gefnffordd a bennir yn erthygl 2 ar yr adegau hynny pan fo'r cyfyngiadau yn erthyglau 4 a 5 yn weithredol.

Cymhwysio

7.—(1) Nid yw'r gwaharddiadau a'r cyfyngiadau yn erthyglau 3, 4, 5 a 6 yn gymwys ond ar yr adegau hynny ac i'r graddau hynny y bydd arwyddion traffig yn eu dangos.

(2) Nid yw unrhyw derfynau cyflymder a osodir gan y Gorchymyn hwn yn gymwys i gerbyd esempt.

Atal Dros Dro

8. Mae unrhyw ddarpariaethau statudol sy'n cyfyngu ar gyflymder cerbydau ar y darn o'r gefnffordd yn erthygl 2 wedi eu hatal dros dro ar yr adegau hynny pan fo'r cyfyngiadau a bennir yn erthyglau 4 a 5 yn weithredol.

9. Bydd y Gorchymyn hwn yn para am 18 mis ar y mwyaf.

6. No person may, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle on the length of the trunk road specified in article 2 during such times as the restrictions in articles 4 and 5 are in operation.

Application

7.—(1) The prohibitions and restrictions in articles 3, 4, 5 and 6 apply only during such times and to such extent as indicated by traffic signs.

(2) No speed limits imposed by this Order apply to an exempted vehicle.

Suspension

8. Any statutory provisions restricting the speed of vehicles on the length of the trunk road in article 2 are suspended during such times as the restrictions specified in articles 4 and 5 are in operation.

Duration of this Order

9. The maximum duration of this Order is 18 months.

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A483, neu gerllaw iddi, wrth Ffordd Osgoi Newbridge, Bwrdeistref Sirol Wrecsam.

Effaith y Gorchymyn yw:

i. gwahardd dros dro pob cerbyd, ac eithrio'r rhai a ddefnyddir gan y gwasanaethau brys neu ar gyfer y gwaith, rhag mynd ar y darn o gefnffordd yr A483 rhwng ganolbwynt Cyffordd 1 (Cyfnewidfa Rhiwabon) ac ochr ogleddol Cylchfan Halton.

Y llwybr arall ar gyfer cerbydau sy'n teithio tua'r de o Gyffordd 1 yw i ddilyn yr A539 tua'r gorllewin, y B5605 tua'r de a'r A5 tua'r dwyrain i ailymuno â'r A483 wrth Gylchfan Halton: i'r gwrthwyneb ar gyfer cerbydau sy'n teithio tua'r gogledd.

ii. gosod terfyn cyflymder o naill ai 50 mya neu 40 mya dros dro a gwahardd goddiweddyd ar yr adegau hynny ar y darn o'r A483 a ddisgrifir uchod.

Disgwylir y bydd y gwaharddiadau a'r cyfyngiadau dros dro yn dod i rym ar 1 Mawrth 2020 ac yn weithredol yn ysbeidiol dros nos (19:00 – 06:00 o'r gloch) am gyfnod o 18 mis ar y mwyaf. Bydd hysbysiad am yr holl waith sy'n cael ei wneud yn ystod y cyfnod hwn yn cael ei arddangos cyn i'r gwaith ddechrau.

**THE A483 TRUNK ROAD (NEWBRIDGE
BYPASS, WREXHAM COUNTY BOROUGH)
(TEMPORARY TRAFFIC PROHIBITIONS &
RESTRICTIONS) ORDER 2020**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A483 trunk road at Newbridge Bypass, Wrexham County Borough.

The effect of the Order is to temporarily:

i. prohibit all vehicles, other than those being used by the emergency services and for the works, from proceeding along the length of the A483 trunk road between Junction 1 (Ruabon Interchange) and the northern side of Halton Roundabout.

The alternative route for southbound vehicles from Junction 1 is via the westbound A539, southbound B5605 and eastbound A5 to re-join the A483 at Halton Roundabout: vice versa for northbound vehicles.

ii. impose either a 50 mph or 40 mph speed limit and prohibit overtaking during such times on the length of the A483 described above.

The temporary prohibitions and restrictions are expected to come into force on 1 March 2020 and operate intermittently overnight (19:00 – 06:00 hours) for a maximum duration of 18 months. Notice of all works being undertaken during this period will be displayed prior to their commencement.
