Regulatory Judgement

Tai Tarian – L154

March 2020

The Welsh Ministers have powers under Part 1 of the Housing Act 1996 to regulate Registered Social Landlords in relation to the provision of housing and matters relating to governance and financial management.

The Welsh Ministers are publishing this Regulatory Judgement under sections 33A and 35 of the Housing Act 1996.

The judgement is published in accordance with the Regulatory Framework for Registered Social Landlords in Wales and the related performance standards.

- Governance and Service Delivery
- Financial Management

Profile

Tai Tarian Limited ("Tai Tarian" or "the Association") is a Registered Social Landlord, created following a large scale voluntary transfer from Neath Port Talbot County Borough Council in March 2011. It is a Community Housing Mutual, owned by its members and registered under the Co-operative and Community Benefit Societies Act 2014, with charitable rules.

Tai Tarian owns and manages over 9,000 homes, which includes more than 430 sheltered homes and provides services to over 500 leaseholders within Neath Port Talbot County Borough.

For the year ending 31 March 2019, the Association's turnover was £49.1m (2018: £46.6m), its surplus was £6.2m (2018: £5.8m) and it employed an average of 505 staff (2018: 512).
