
Figure 17.1 Multiple Index of Deprivation, Quintiles within Wales


Figure 17.2 Health Deprivation, Quintiles within Wales


































































































FIGURE 8.22 (BADGER SURVEY RESULTS SUMMARY) IS CONFIDENTIAL AND IS THEREFORE NOT INCLUDED WITHIN THIS VERSION OF THE ENVIRONMENTAL STATEMENT.





















































