Consultation on Brexit and our Land – Securing the future of Welsh farming

In July 2018 I published the above consultation. The purpose of this consultation is to explain we propose closing the Basic Payment Scheme and Glastir and replacing with new schemes. I have spent the summer discussing 'Brexit and our Land' with as many farmers as possible.

Our current EU membership means you benefit from access to a very large, tariff-free and frictionless market. Additionally, the external tariffs put in place by the EU prevent large amounts of agricultural products from the rest of the world being imported into EU countries (including the UK).

As yet, we do not know what trade deal we will have after Brexit, so we are unable to make detailed plans. However the different trade deals which we may end up with will bring opportunities and risks to different sub-sectors.

For farm businesses to be able to withstand these changes, we need to invest in businesses differently with targeted investment to improve productivity to diversify into other income streams and to adapt to new market pressures and opportunities. Farming needs to be sustainable, economically, socially and environmentally, if we are to have the prosperous and resilient sector we all want.

If Welsh farm businesses do not adapt to these new pressures, it will become increasingly difficult to compete in the global markets Brexit will expose us to. Current payments made to you do not and will not help you manage.

We have proposed a new **Economic Resilience Scheme** to support our farm businesses to continue to produce high quality food.

Food production alone is not enough to sustain some farm businesses due to declining markets, constraints of topography or a lack of diversification options. Therefore, we have proposed a new **Public Goods Scheme** to create an additional and meaningful income stream for farmers able to supply those environmental services we all depend on but are not currently supported by the market. For example, there is no market to pay farmers to manage their land in such a way as to reduce flood risk.
