Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer cefnffordd yr A487, drwy arfer y pwerau a roddir iddynt gan adrannau 84(1)(a), 84(1)(c), (1A) a (2) o Ddeddf Rheoleiddio Traffig Ffyrrd 1984(1), ac ar ôl ymgynghori â Phrif Swyddog Heddlu Dyfed-Powys, yn gwneud y Gorchymyn hwn.

**Enwi, Cychwyn a Dehongli**

**1.** Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A487 (Aberaeron, Ceredigion) (Terfynau Cyflymder 40 mya ac 20 mya) 2020 a daw i rym ar 5 Hydref 2020.

**2.** Yn y Gorchymyn hwn—  
ystyr “cerbyd esempt” (“exempted vehicle”) yw:  
(a) unrhyw gerbyd sy'n cael ei ddefnyddio at y dibenion a ddisgrifir yn adran 87 o Ddeddf Rheoleiddio Traffig Ffyrrd 1984(2);

(1) 1984 p. 27; amnewidiwyd adran 84(1) ac adran 81(1A) gan adran 45(2) o Ddeddf Traffig Ffyrrd 1991 (p. 40). Amnewidiwyd adran 84(2) gan baragraff 61 o Atodlen 8 i Ddeddf Ffyrrd Newydd a Gwaith Stryd 1991 (p. 22). Yn rhinwedd O.S. 1999/672, ac adran 162 o Ddeddf Llywodraeth Cymru 2006 (p. 32), a pharagraff 30 o Atodlen 11 iddi, mae'r pwerau hyn yn arferadwy bellach gan Weinidogion Cymru o ran Cymru.

The A487 Trunk Road (Aberaeron,  
Ceredigion) (40 mph & 20 mph  
Speed Limits) Order 2020

*Made* 29 September 2020  
*Coming into force* 5 October 2020

The Welsh Ministers, as traffic authority for the A487 trunk road, in exercise of the powers conferred upon them by sections 84(1)(a), 84(1)(c), (1A) and (2) of the Road Traffic Regulation Act 1984(1) and after consultation with the Chief Officer of Dyfed-Powys Police, make this Order.

**Title, Commencement and Interpretation**

**1.** The title of this Order is the A487 Trunk Road (Aberaeron, Ceredigion) (40 mph & 20 mph Speed Limits) Order 2020 and it comes into force on 5 October 2020.

**2. In this Order—**

“exempted vehicle” (“cerbyd esempt”) means:

(a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984(2);

(1) 1984 c. 27; section 84(1) and section 81 (1A) were substituted by the Road Traffic Act 1991 (c. 40), section 45(2). Section 84(2) was substituted by the New Roads and Street Works Act 1991 (c. 22), Schedule 8, paragraph 61. By virtue of S.I. 1999/672, and section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c. 32), these powers are now exercisable by the Welsh Ministers in relation to Wales.

(2) Section 87 was amended by the Fire and Rescue Services Act 2004 (c. 21), Schedule 1, paragraph 55, the Serious Organised Crime and Police Act 2005 (c. 15), Schedule 4, paragraph 42, the Crime and Courts Act 2013 (c. 22), Schedule 8, paragraph 29(2), and the Deregulation Act 2015 (c. 20), section 50(4) and (5).

(b) unrhyw gerbyd sy'n cael ei ddefnyddio at ddibenion y llynges, y fyddin neu'r llu awyr ac sy'n cael ei yrru gan berson sydd am y tro yn ddarostyngedig i orchmyntion aelod o lloedd arfog y Goron, sy'n aelod o'r lloedd arbennig—

- (i) ac sydd wedi ei hyfforddi i yrru ar gyflymderau uchel ac sy'n gweithredu wrth ymateb, neu wrth ymarfer ymateb, i argyfwng diogelwch gwladol; neu
- (ii) at ddiben hyfforddi person i yrru cerbydau ar gyflymderau uchel;

ystyr “y gefnffordd” (“*the trunk road*”) yw cefnffordd yr A487 Abergwaun i Fangor; ac

ystyr “lluoedd arbennig” (“*special forces*”) yw'r unedau hynny o'r lluoedd arfog y mae Cyfarwyddwr y Lluoedd Arbennig yn gyfrifol am gynnal eu galluoedd neu sydd am y tro yn ddarostyngedig i reolaeth weithredol y Cyfarwyddwr hwnnw.

(b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—

- (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
- (ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director; and

“the trunk road” (“*y gefnffordd*”) means the A487 Fishguard to Bangor trunk road.

## Cyfngiadau

**3.** Ni chaiff neb yrru unrhyw gerbyd modur, ac eithrio cerbyd esempt, yn gyflymach nag 20 milltir yr awr ar y darn o'r gefnffordd a ddisgrifir yn Atodlen 1 i'r Gorchymyn hwn.

**4.** Ni chaiff neb yrru unrhyw gerbyd modur, ac eithrio cerbyd esempt, yn gyflymach nag 20 milltir yr awr ar y darn o'r gefnffordd a ddisgrifir yn Atodlen 2 i'r Gorchymyn hwn.

**5.** Ni chaiff neb yrru unrhyw gerbyd modur, ac eithrio cerbyd esempt, yn gyflymach na 40 milltir yr awr ar y darn o'r gefnffordd a ddisgrifir yn Atodlen 3 i'r Gorchymyn hwn.

## Cymhwysedd

**6.** Nid yw'r cyfngiad yn erthygl 3 yn gymwys ond ar yr adegau hynny ac i'r graddau hynny y bydd arwyddion traffig yn eu dangos.

## Restrictions

**3.** No person may drive any motor vehicle, other than an exempted vehicle, at a speed exceeding 20 miles per hour on the length of the trunk road described in Schedule 1 to this Order.

**4.** No person may drive any motor vehicle, other than an exempted vehicle, at a speed exceeding 20 miles per hour on the length of the trunk road described in Schedule 2 to this Order.

**5.** No person may drive any motor vehicle, other than an exempted vehicle, at a speed exceeding 40 miles per hour on the length of the trunk road described in Schedule 3 to this Order.

## Application

**6.** The restriction in article 3 applies only during such times and to such extent as indicated by traffic signs.

**SCHEDULE 2**  
**20 mph Speed Limit**

The length of the trunk road at Aberaeron, Ceredigion that extends from a point 14 metres north-east of the centre-point of its junction with Wellington Street to a point 13 metres north-east of the centre-point of its junction with Regent Street.

**SCHEDULE 3**  
**40 mph Speed Limit**

The length of the trunk road at Aberaeron, Ceredigion that extends from a point 782 metres south-west of the centre-point of its junction with the road leading to the offices of Ceredigion County Council to a point 81 metres south-west of the centre-point of that junction.

Mae Gweinidogion Cymru wedi gwneud Gorchymyn drwy arfer eu pwerau o dan adrannau 84(1)(a), 84(1)(c), (1A) a (2) o Ddeddf Rheoleiddio Traffig Ffyrd 1984, sy'n dod i rym ar 5 Hydref 2020.

Effaith y Gorchymyn yw cyflwyno terfyn cyflymder 20 mya ar y darn o gefnffordd yr A487 a ddisgrifir yn Atodlen 1 i'r Hysbysiad hwn. Bwriedir i'r terfyn cyflymder 20 mya fod yn gymwys am gyfnodau cyfyngedig o'r dydd yn ystod y tymor ysgol pan fydd arwyddion traffig yn dangos hynny: bydd y terfyn cyflymder 30 mya presennol yn parhau mewn grym ar bob adeg arall. Mae ymchwiliadau wedi dangos bod cyflymder traffig ar hyn o bryd yng nghanol y dref yn cyflawnhau terfyn cyflymder 20 mya gan fod y dystiolaeth ddiweddar yn dangos bod pob gwrthdrawiad a gofnodwyd wedi digwydd ar hyd y darn hwn o gefnffordd yr A487.

Caiff terfyn cyflymder 40 mya ei gyflwyno ar y darn o gefnffordd yr A487 a ddisgrifir yn Atodlen 3 i'r Hysbysiad hwn. Bydd hyn yn gostwng cyflymder traffig ar y ffordd tua'r gogledd sy'n arwain at yr ysgol a hefyd yn creu clustogfa rhwng y terfyn cyflymder 60 mya a'r terfyn cyflymder 20 mya a fydd yn diogelu holl ddefnyddwyr y ffordd.

**THE A487 TRUNK ROAD (ABERAERON,  
CEREDIGION) (40 MPH & 20 MPH SPEED  
LIMITS) ORDER 2020**

The Welsh Ministers have made an Order in exercise of their powers under sections 84(1)(a), 84(1)(c), (1A) and (2) of the Road Traffic Regulation Act 1984, which comes into force on 5 October 2020.

The effect of the Order is to introduce a 20 mph speed limit on the length of the A487 trunk road described in Schedule 1 to this Notice. The 20 mph speed limit is intended to apply for limited periods of the day during school term time when indicated by traffic signs; at all other times the existing 30 mph speed limit will remain in force. The reduced speed limit during these periods is intended to reduce the speed of traffic and promote pedestrian safety near Aberaeron Primary School at Aberaeron, Ceredigion.

A 20 mph speed limit will also be introduced on the length of the A487 trunk road described in Schedule 2 to this Notice. Investigations have shown that existing traffic speeds in the centre of the town warrant a 20 mph speed limit as recent evidence indicates all recorded collisions were located along this length of the A487 trunk road.

A 40 mph speed limit will be introduced on the length of the A487 trunk road described in Schedule 3 to this Notice. This will reduce the speed of traffic on the northbound approach to the school and will create a buffer zone between the 60 mph and 20 mph speed limits, which will safeguard all road users
